1. That the complainant and the accuseds as well as

3. That the father of the complainant planted so many  
trees during his life time for fire wood and one of the  
"Sonajuri" tree became a great one having his branches  
of big size.

4. That the accused persons on 11th Jaistha last  
Saturday (26/05/2018) being <sup>armed</sup> ~~armed~~ with various weapons  
in their hands entered into the land of the complainant  
at about 7/8 A.M. and started to cut the "Sonajhuri"  
tree of the complainant.

5. That the complainant raised protest for such forcibly cutting of tree of the complainant when all the accuseds chased the complainant with deadly weapons in their hands with a view to cause murder to the complainant.

6. That due to hue and cry the witnesses and other villagers assembled thereat and they advised the complainant not to quarrel with them but to inform to O.C. Joypur P.S.

7. That on that day the complainant informed at Joypur P.S. in writing but the Police as did not take any steps and thereafter the complainant lodged information to S.P. Purulia on 04/06/2018 but neither the Police of Joypur P.S. nor the S.P. Purulia took any steps for which the complainant has been compelled to file this petition before the Ld. Court.

8. That the accused persons after cutting the "Sonajhuri" tree from the plot of the complainant kept the same in their nearby plot and if the police would have taken step the search and seizure ought to have done.

9. That the valuation of the cut tree is about Rs. 16/20 thousand which the accuseds have taken away after forming an unlawful assembly criminally trespassed into the lands of the complainant for which all the accused are liable to be punished.
