On 18.07.2018 at about 6.55 A.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 1. Ganesh Mahato, Gr1 TSH 2. Shibaram Mahato, HG TSH entered the premises of Basudeb Gorain s/o Rasan Gorain of village: Chaitandi, P.O- Ramamoti, P.S- Joypur , Dist- Purulia and found Basudeb Gorain s/o Rasan Gorain was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through AL cable by means direct hooking to his house premises and connected load found 1.26 KW.
