On 18.07.2018 at about 7.20 A.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 1. Ganesh Mahato, Gr1 TSH 2. Shibaram Mahato, HG TSH entered the premises of Arjun Gorain s/o Lt. Mukuru Gorain of village: Chaitandi, P.O- Ramamoti, P.S- Joypur, Dist- Purulia and found Arjun Gorain s/o Lt. Mukuru Gorain was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSIEDCL through CU cable by means direct hooking to his house premises and connected load found 0.57 KW.
