On 20.07.2018 at about 7.30 P.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 1. Souvik Bera, SE&RM, Purulia Regional Office 02. Chanchal Mondal, DE(E), Purulia Regional Office 03. Sorood Iqbal, AE(Tech), Jhalda HTMC. 04. Ganesh Mahato, Gr1 TSH, Joypur CCC 05. Shibaram Mahato, HG TSH, Joypur CCC, 06.
