Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Nirmal Garai S/O LT. Lalu Garai Vill+ PO- Sonaijuri Dist-PURULIA has committed theft of Electricity U/S-135(1)(a) of the Electricity Act 2003,(Amendment) Act-2007.

On dated 16.07.2018 I received a secret complain over telephone that Sri Nirmal Garai S/O LT. Lalu Garai Vill+ PO- Sonaijuri Dist-PURULIA consuming electricity by means of Tapping from incoming side of meter of WBSEDCL .

On the basis of said complaint at about 12.45 pm. I, Sri Mrinal Chowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

- 1) S & LP wing from RM Office Purulia &
- 2) Sri Dipak Kr. Bhowmik, SAE, Kashipur CCC
- 3) Sri Sanjoy Garain, OE Kashipur CCC.

Entered the premises of Sri Nirmal Gorai S/O LT. Lalu Gorai Vill+ PO- Sonaijuri Dist-PURULIA and found that sri Garai consuming electricity dishonestly by broken of seal and by-passing the meter through a wire from incoming side to stop actual registering of unit . Then we disconnect his service line ,seized the meter bearing no-B3777786, make-Bentec alongwith PVC 1.5 metre and broken seal no XE0307250 . Load found-fan-2 , cfl-2 nos, TV- 1 Nos Total-0.42 KW.

After preparation of proper seizure list The seizure list are prepared at the site and the accused person refuse to sign in the seizer list. The inspection team left the above premises at about 01.15 pm. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
