

Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that,Sri Kalipada Bouri S/O-LT.Kailash Bouri, Vill- Lipidih (Babirdih), PO-Gouragdi, PS- Kashipur Dist- Purulia for theft of energy by means of tapping of service cable before entering the meter of WBSEDCL.

On dated 19.07.2018 | received a secret complain over telephone that Kalipada Bouri S/O-LT.Kailash Bouri, Vill-Lipidih (Babirdih), PO-Gouragdi, PS-Kashipur Dist-Purulia using electricity illegally for his house and pay a minimum consumption bill as compared to his actual consumption.

On the basis of said complaint at about 01.55 p.m. I, Sri MrinalChowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

- 3)Sanjoy Garain, OE, ,Kashipur CCC

Entered the premises of Sri Kalipada Bouri S/O-LT.Kailash Bouri , Vill- Lipidih and found that he is consuming electricity dishonestly by means of tapping from incoming side of service cable before entering the meter of WBSEDCL. The existing meter no is 497724 make TGL

Total Load found approx 0.3 KW. (, Fan-2,, CFL-5, TV-1 no)

Then we disconnect his permanent connection also ,seized the following articles.

- 1) Energy Meter- 1no(Make- TGL, SL no-497724
- 2) Cut out-16 amp-1 no and one MCB all are fitted with one fiber board alongwith tapping point. after preparation of proper seizure list. The seizure list are prepared at the site and the representative of accused person refuse to sign in the seizer list. The inspection team left the above premises at about 02.15 p.m. The accused person has committed an offence U/S-135(i)(a)(b) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
