Respected Sir,

In producing herewith one arrested accused namely Bholanath Hembram (55), S/O - Lt Gorachand Hembram of village-Majuramura, Tola Chhutardih, PS-Kashipur, Dist- Purulia along with seized articles, I beg to report that on 25.07.18 at about 17.35 hrs in course of mobile duty myself along with force got reliable source information that one person is selling country liquor at village Majuramura, Tola Chhutardih in his house. Accordingly myself along with C/1192 Raicharan Majee and C/657 Jaharlal Murmu both of Kashipur P.S reached at Majuramura, Tola Chhutardih village at about 18.05 hrs and found that one person was selling C.S.liquor in hishouse. After seeing police party liquor customers fled-away from the spot. On demand the seller failed to produce any valid document for selling C.S. liquor in his possession. So the above noted accused has committed an offence U/S -46(A)(c) B.E. Act 1909 Amended up-to date. During search I found (1) 25 (Twenty five) sealed bottles of DILKHUSH C.S. liquor (600 ml each) (2) 05(Five) empty bottles of DILKHUSH C.S. (3) 04 (Four) Plastic Tea Glass (4) Rs.120/-(One hundred Twenty) as sale proceed, accordingly I seized the above noted articles under proper seizure list duly signed by the witnesses in between 18.15 hrs. to 18:35 hrs. I also seized and labeled bottles with sample C.S. liquor at the spot in presence of accused person and witnesses. Accordingly I arrested the above noted accused person U/S- 67 Bengal Excise Act 1909 and informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with seized above noted articles.

Therefore I pray before you that kindly arrange to start a specific case under proper section of law U/S 46(A)(c) B.E. Act 1909 against arrested accused namely Bholanath Hembram (55), S/O - Lt Gorachand Hembram of village-Majuramura, Tola Chhutardih, PS- Kashipur, Dist- Purulia and arrange for its investigation.
