

begs to state as follows :-

- That, the Complainant and accused persons have friendship and known to each other having good relationship prior to the date of incident.
- That, the accused person have purchased a
 Bolero Pick-up Van bearing Registration No. WB-55-8514.

 And when he was not in a position to ply the vehicle and facing monetory loss due to not useing the Vehicle for business purpose. He proposed to sale the same at a markatable & price.
- That, thereafter the accused person approached the Complainant to Purchase the said Vehicle. And after after due neogotiation Rs. 3,10,000/- (Rupees Three Lakh Ten thousand) only was fix for the cost or value of the said Vehicle.
- That, after agreement the Complainant paid

 Rs. 1,75,000/- (Rupees One Lakh Seventy Five thousand)

 only the the Complainant on 01/05/2017 and the accused

 person acknowledged the same and after receiving the

 said amount it was also agreed that the balance amount

 i.e. Rs. 1,55,000/- (Rupees One Lakh Fifty Five thousand)

Complainant to the accused. When he transfered the Ownership of the vehicle before the concerned authority. But in no care that to be done within one month.


- 5) That, after one month the Complainant fequested the accused person to take the said balance amount and to transfer the ownership of the vehicle in his name.
- 6) That, the accused person since the date of receiving the said advance amount till today diferred to the matter on same false pretext.
- 7) That, mean while the Complainant could under stood the ill intention of the accused person.

Then the Complainant accused person and some others including the witnesses tried to compromise MAKKE matter.

When the accused denied to sell the said Vehicle but promised that he will return back the advance amount i.e. Rs. 1,55,000/- after deducting Rs. 20,000/- i.e. for processing fees or misuses charges. However the Complainant agreed with the same, one documents was prepared to that effect on 12/12/2017 wherein the accused person promised to pay back the said amount on Contd... page No.- 4. 05/01/2018.



- 8)____ That, after 05/01/2018 and thereafter also the Complainant requested the accused persons either to return him the amount i.e. Rs. 1,55,000/- or to sale him the vehicle after taking the balance amount.
- 9) That, the accused person is still kept the vehicle in his possession and doing business and earns money.
- That, presently the accused person became very much hostile and agreesive to the Complainant and when the Complainant put pressure upon the accused then the accused abushed him and assaulted him. And gave out that he would do whatever he likes.
- That, the intention of the accused person is otherwise and due to such the Complainant is suffering monetory loss and so given to the accused person which is also harmful to the mind, reputation and became very much defamed.
- 12) That, initially the vehicle was handed over to the Complainant but after some days the accused person forcefully take back the Vehicle in his custody and is still in his possession.
- 13) ____ That, the accused person in the above manner



cheated the Complainant for which he is deserved to be punished under the Penal Law.

14) That, the Complainant reported the matter to the O/C. Kenda P.S. then to S.P., Purulia but no such legal action is taken against the accused person.

Hence, the Complainant is filing this Complaint again against the accused person before the Ld. Court under the Law.

It is therefore prayed that, your Honour may be pleased to sent this & Complaint to the O/C. Kenda P.S. for treating it as F.I.R. U/S. 156(3) Cr.P.C.
