I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Shibu Bauri S/O- Kalipada Bauri of Village- Manbazar, P.O- Manbazar P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 12-07-18 at about 06.00 PM, Sri Swarnap Mandal Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Shibu Bauri, S/O- Kalipada Bauri of Village- Manbazar, P.O- Manbazar, P.S.- Manbazar, Dist - Purulia and inspected his/her premises and found that he was using electricity unauthorisely by direct hooking from WBSEDCL LT OHT system.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)( ) was detected. It was also found that he/she was using the following electrical equipments -
