Sir,

I beg to state that on 21st June, 2018, while my husband namely Dr. Gautam Deb Mandal, Dy. C.MO going to attend his duty at Parbelia colliery by riding on the back of a motor cycle driven by Bijoy Hasi s/o Sufal Hasi of Parbelia 8 NO. Basti being Registration No. - WB38 S 6980 and the moment ^{at about 9:30 a.m} the motor cycle almost crossing the Subhas Setu, suddenly a truck being Registration No. - WB41 C 6631 coming from Disergash side with very high speed hit and dashed the motor cycle on the back as a result Dr. Mandal sustained multiple injury and fracture in right hip joint, right leg and other lacerated injury on his body. Immediately he was then and then shifted to Sanctoria Hospital where from he was referred to Mission Hospital, Durgapur and condition of Dr. Mandal was very serious and treated under ventilation. I being the wife and only elder member of the family

engaged for his management and treatment and he presently under the care of ICU surgical at Mission Hospital, Durgapur due to which I am unable to attend the P.S for lodging F.I.R. His condition is still not stable. Be it stated herewith that the two wheelers driver and my husband were wearing helmet while going to duty.

I, therefore, request you to lodge a F.I.R. against driver of the offending vehicle being no. WB 41C 6631 for his driving the truck with rash and negligent manner and I hope you condone the delay due to reason stated above.
