Electricity was detected i.e he was enjoying electricity dishonestly
by drawing illegal hooking from the nearest LTOH of WBSEDCL
i.e u/s 135 (1) (a) was detected.

From the above arrangement he was using the following
electrical equipment viz :- ① One no Electric Bulb - 100 watt
② One no Electric fan - 40 watt out of which I seized the
following :- ① Two Core PVC Cable with hooking device of length
27 feet approx.
② One no Electric Bulb with holder - 100 watt.
