Sir, I do hereby lodge Complaint empowered by enabling the Electricity act 2003 duly amended on 2007 to the effect that on ^{Yesterday} today (11-07-2018) Sri Anmit Banni s/o - Kartic Banni of vill - Astha Ps - Nelmia dist - Purulia was enjoying electricity unauthorisedly i.e. by direct hooking from nearest LTOT of WBSEDCL and due to this reason he has committed theft of electricity u/s 135 (1) (a) of the electricity act.

on (11-7-2018) at about - 19:55 hrs I, Sibdas Baul, Station Manager Satore cee alongwith ① Sri Gotionmay Das, SAE(E) ② Sri Kanai Saha, LM ③ Sri Gouram K's Pandey, Hq, TSH entered the premises of Sri Anmit Banni s/o - Kartic Banni and impounded the premises. During impaction theft of electricity was detected i.e. he was using electricity dishonestly by drawing illegal hooking from nearest LTOT of WBSEDCL i.e. u/s 135(1)(a) was detected.

from the above arrangement he was using the following electrical equipment viz:- ① Electric Bulb 01 no (100 watt) ② Electric fan - 01 no (40 W). out of which I seized the following:-

① Single Core PVC Cable with hooking device of length 30ft approx assorted size.

② One no electric Bulb with holder - 100 watt.

Seizure list was prepared at the site and the accused person refused to sign on it.
