In Producing herewith 04 (Four) arrested accused persons namely (1) Sonu Singh (29) S/O- Nirmal Singh of Parbelia new colony 03 No, PS- Neturia, Dist- Purulia (2) Bale Hembrom (28) S/O- Lt. Joyakim Hembrom of Vill- Parudhowra near Parbelia New Colony, PS-Neturia, Dist-Purulia, (3) Firoz Alam (24) S/O- Md. Islam of Vill- Parbelia Amdhowra, PS- Neturia, Dist- Purulia (4) Surendra Rajak (41) S/O- Lt. Baleswar Rajak of Parbelia Hattola, PS- Neturia, Dist- Purulia, and seized articles (i) One Black, Blue & silver colour laptop (Make- Dell, Model- Inspiron 1440, Sl. No- 918Q0K1) being installed with a online gaming software/app named as "Play India Casino" along with one power cable (ii) One white colour printer, make-Epson, Sl. No- TUBG315725, fitted with one data cable (iii) one black colour mouse make-Xcess (iv) Cash Rs. 28,970 /- (Rs. 2000X4, 500 X29, Rs.200X1, Rs.100X49, Rs. 50X4, Rs. 20X48, Rs. 10X 21) (v) One black colour Jiofi modem having IMEI No- 911572251752925, Make Id- 40C8CB11EEFC fitted with one Jio Sim card having ICC ID. No- 89918740408056607259 (getting after opening up the back cover) (vi) plastic chair 04 pieces (vii) plastic table 01 piece.

I beg to state that I, SI Anirban Dutta of Neturia PS, do hereby lodged complaint to the effect that on 16.07.18 at 19:05 hrs, SI Basudev Samanta who was on table duty received an information that one Sonu Singh S/O- Nirmal Singh of Parbelia new colony, PS- Neturia, Dist- Purulia in association with one Jitendra Kumar Singh of Kolkata side along with above noted accused persons had arranged an online gambling in the shop of Sonu Singh near Parbelia Kanta, beside Purulia - Barakar road pitch road under PS- Neturia. SI Basudev Samanta noted the information on PS GDE book vide Neturia PS GDE No- 837 dated- 16.07.18 and informed you about the information received. You directed me along with other officers & force to work out the information.

As per your direction myself along with C- 584 Madhab Majee, C-1224 Gajan Murmu left PS at 19:15 hrs for Parbelia Kanta to work out the information vide Neturia PS GDE No- 838 dated- 16.07.18 and CC No- 2264/18 dated- 16.07.18, with Govt. vehicles bearing Regd. No WB56C/8993 and also directed ASI Deb Kumar Chattaraj along with C/278 Ashok Chandra, C/382 Bipad Taran Chatterjee, C/1260 Santosh Soren, all of Neturia PS who were engaged in evening mobile duty, to come at nearby Parbelia Kanta quickly. At 19:25 hrs, we assembled at nearby Parbelia Kanta and kept vehicles there and approached towards the shop of Sonu Singh on foot and at 19:35 hrs, we reached in front of said shop which is situated beside Purulia- Barakar pitch road and tried to surround the shop and found that about 6/7

persons are playing online gambling on exchange of money in the shop with the help of one lap top connecting with internet. The organizer Sonu Singh S/O- Nirmal Singh of Parbelia new colony, PS- Neturia, Dist- Purulia was also physically present.

By this time the assembled persons somehow smelled the presence of police and few of them managed to escape. Entering into the shop we found that they were playing online gambling with the help of one silver, black & blue colour laptop being networked via a black colour Jiofi modem. However, we apprehended 04 (four) persons. Being asked they disclosed their identity as noted above. I seized and labeled the following articles from the shop under proper seizure list.

(i) One Black, Blue & silver colour laptop (Make- Dell, Model- Inspiron 1440, Sl. No- 918Q0K1) being installed with a online gaming software/app named as "Play India Casino" along with one power cable (ii) One white colour printer, make-Epson, Sl. No- TUBG315725, fitted with one data cable (iii) one black colour mouse make-Xcess (iv) Cash Rs. 28,970 /- (Rs. 2000X4, 500 X29, Rs.200X1, Rs.100X49, Rs. 50X4, Rs. 20X48, Rs. 10X 21) (v) One black colour Jiofi modem having IMEI No- 911572251752925, Make Id- 40C8CB11EEFC fitted with one Jio Sim card having ICC ID. No- 89918740408056607259 (getting after opening up the back cover) (vi) plastic chair 04 pieces (vii) plastic table 01 piece.

The arrested accused persons and others were causing wrongful gain for someone and wrongful loss to others at a same time by way of playing online gambling sitting in the shop. Sonu Singh allowed the arrested persons and others to do the same by sitting in his shop without any Constitutional authenticity. As such the arrested persons and Jitendra Kumar Singh of Kolkata side and others are liable for prosecution U/S-3/4 W.B G & P. C. Act, 1957.

Therefore after producing the arrested accused & seized article I pray before your good self, a specific case may kindly be initiated against (1) Sonu Singh (29) S/O- Nirmal Singh of Parbelia new colony 03 No, PS- Neturia, Dist- Purulia (2)Bale Hembrom (28) S/O- Lt. Joyakim Hembrom of Vill- Parudhowra near Parbelia New Colony, PS-Neturia, Dist-Purulia, (3) Firoz Alam (24) S/O- Md.Islam of Vill- Parbelia Amdhowra, PS- Neturia, Dist- Purulia (4) Surendra Rajak (41) S/O- Lt. Baleswar Rajak of Parbelia Hattola, PS- Neturia, Dist- Purulia and (5) Jitendra Kumar Singh of Kolkata side & 2/3 others under proper section of law.
