of Saltore Customers Care Counter had been at Baranipara village
for Deemed disconnected Premises visit. During the work we have
seen one cable with hooking arrangement has been connected
to WBSEDL's LTOH line and upon chasing the cable we found
the cable entered into the premises of Sri Pappu Sharma ~~and~~ and
the inspection team entered into the premises followed by serving
one notice. After thorough inspection it has been cleared that
Sri Pappu Sharma using electricity dishonestly by drawing illegal
hooking from the nearest LTOH of WBSEDL, i.e 135(1)(a) detected

from the above arrangement he was using the following equipment
viz ^① Lamp - 02 nos (60w each) ^② Electric fan - 02 nos (80w each) ^③ TV -
01 NO (100w) ^④ Electric Air Cooler - 01 NO (160watt) ^⑤ Electric water Pump - 01 NO.
(323 watt) e.t.c Total load found - 0.913 KW.

- ① Two Core PVC Cable - 06 sqmm with hooking arrangements of Ranti length - 41 feet approx.
- ② Two nos Electric Bulb with holder - 60 watt each.

Seizure list was prepared at the site and the accused person signed on it. One copy of seizure list has been handed over to the accused.

The Inspection team left the premises on 24/07/2018 at about 17:10 Hrs.

In this context it has been also observed from available office record that the accused person had one electric connection against Commr id - "201876034" which was deemed terminated due to non payment of energy bill having OSD of RS - 20,845/- on date.

The accused person has committed an offence u/s. 135(1)(a) of the Electricity Act & 2003 duly amended on 2007.

You are requested to take cognizance of the complaint and treat it as FIR and action may be taken as per rule. I handed over to you inspection report, seizure list in original and seized articles on per Seizure list for further necessary action.
