Sir, I do hereby lodge Complaint empowered by enabling the electricity act 2003 duly ammended on 2007 that to the effect <sup>21/7/18</sup> ~~(24/7/18)~~ Sri Pappu Sharma s/o - Lt Beharashi Sharma was enjoying electricity un-authorizedly i.e by means of direct hooking from nearest LTOH of WBSEDCL and due to this reason he has committed theft of electricity u/s- 135(1)(a) of the Electricity Act 2003 duly ammended on 2007.

On (24-07-2018) at about 16:40 hrs I. Sibdas Ball s/o - Dilip Kr Ball, Station Manager Saitore Customer Care Centre alongwith Sri Pradip Chowdhury, Divisional Manager, Raghmathpur Division, Sri Suman Banarjee, Sr. SAE (E), Raghmathpur Division, Sri Gopinoy Dass, SAE (E) Sri Kamal Sarna, LM Sri Gouram Kr Pandey, Hg TSH of Saitore Customer Care Centre had been at Baranipara village for deemed disconnected premises visit. During the work we have seen one cable with hooking arrangement has been connected to WBSEDCL's LTOH line and upon chasing the cable we found the cable entered into the premises of Sri Pappu Sharma and the impetion team entered into the premises followed by serving one notice. After thorough impetion it has been cleared that Sri Pappu Sharma using electricity dishonestly by drawing illegal hooking from the nearest LTOH of WBSEDCL, i.e 135(1)(a) detected

from the above arrangement he was using the following equipment viz ① Lamp - 02 nos (60w each) ② Electric fan - 02 nos (80w each) ③ TV - 01 no (100w) ④ Electric Air Cooler - 01 no (160 watt) ⑤ Electric water pump - 01 no (373 watt) i.e Total load found - 0.913 KW.

The Inpution team left the Premises on- 24/07/2018 at about 17:10 Hrs.

In this Context it has been also observed from available office record that the accused Person had one Electric Connection against Connid - 201876034 which was deemed terminated due to non payment of Energy bill having OSD of RS - 20,845/- as on date.

The accused Person has Committed an offence u/s. 135(1)(a) of the Electricity act 2003 duly ammended on 2007.

You are requested to take Cognizance of the Complaint and treat it as FIR and action may be taken as per rule. I handed over to you Inpution report, Seize list in original and seized articles as per Seizure list for further necessary action.
