In producing herewith one arrested accd. person namely Dilip Mudi (37 yrs) s/o Pabitra Mudi of Vill- Durgasing danga, Bagalia,, PS- Para, District - Purulia with seized article i.e 15 (fifteen) sealed bottles of Country Spirit styled as "DIL Se" each Bottle contains 600 ml along with 30(Thirty) pcs plastic glass from which 01 (One) bottle collected as sample, which was seized & level under proper seizure list.

I beg to submit that today (08.07.2018) during my mobile duty as well as raid duty in between 06.15 hrs to 06.25 hrs acting on a source information a raid was conducted in the house of Dilip Mudi (37 yrs) s/o Pabitra Mudi of Vill- Durgasing danga, Bagalia,, PS- Para, District - Purulia and found that the above noted person was keeping and selling Country Spirit which were kept at his house. On being demand he failed to produce any valid document in respect of keeping and selling of said liquor. As such I seized 15 (fifteen) sealed bottles of Country Spirit styled as "DIL Se" each Bottle contains 600 ml along with 30(Thirty) pcs plastic glass from which 01 (One) bottle collected as sample, which was seized & level under proper seizure list in presence of witnesses duly signed by them and also arrested the above noted accd. person.

The above noted arrested accd. namely Dilip Mudi S/o Pabitra Mudi of Vill- Durgasing danga, Bagalia,, PS- Para, District - Purulia committed offence u/s 46 A(c) B.E. Act. 1909 for unauthorized possession and sale of country spirit in his house.

Under the above fact and circumstance I pray that a case u/s 46 A (c) B.E. Act'1909 may kindly be started against Dilip Mudi S/o Pabitra Mudi of Vill- Durgasing danga, Bagalia,, PS- Para, District - Purulia and arrange for its investigation.
