Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that **MONTU BAURI, S/O-Late Dasu Bauri Village-Para,P.S.-Para, Dist-Purulia**, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a)of Electricity Act. 2003 read with amendment of Electricity Act. 2007.


On 13.07.2018 at about 6:05PM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C,along with Mr.Avishek Das, SAE(E), Dubra Para CCC and Mr. Lakshman Mahato, HG.SR.LM , Dubra Para CCC inspected the premises of **MONTU BAURI, S/O-Late Dasu Bauri of Village-Para, P.S.-Para, DistPurulia**. During inspection it was found that the said **MONTU BAURI**, was enjoying electricity unauthorizedly by direct tapping of service cable as hooking arrangement from WBSSEDCL's nearest low tension over head line for running his 02nos bulb, 01 no fan, 02 nos CFLapprox load 0.198 KW for domestic purpose, which is an offence u/s. 135 (1)(a)of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSSEDCL. The inspection team left the site at about 6:20PM.

As such **MONTU BAURI, S/O-Late Dasu Bauri Village-Para,P.S.-Para, Dist-Purulia**, has committed an offence of theft of electricity under section 135 (1)(a)of Electricity Act. 2003 read with amendment of Electricity Act. 2007.So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
