On 13.07.2018 at about 6:45PM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with Mr.Avishek Das, SAE(E), Dubra Para CCC and Mr. Lakshman Mahato, H.G. SR. LM, Dubra Para CCC inspected the premises of *KASINATH BAURI* S/O- Manesh Bauri of Village-Para, P.S.-Para, DistPurulia.
