In producing herewith one arrested accd. person namely Satrughna Kaibartya (38yrs) S/o Nibaran Kaibortya of Vill- Indtard, PS- Para, District - Purulia with seized article i.e 20 (Twenty) sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml which 01 (One) bottle collected as sample, which was seized & level under proper seizure list.

I beg to submit that today (15.07.2018) during my mobile duty as well as raid duty in between 20.05 hrs to 20.45 hrs acting on a source information a raid was conducted in the house of Satrughna Kaibartya (38yrs) S/o Nibaran Kaibortya of Vill- Indtard, PS- Para, District - Purulia and found that the above noted person was keeping and selling Country Spirit which were kept at his house. On being demand he failed to produce any valid document in respect of keeping and selling of said liquor. As such I seized 20 (twenty) sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml in which 01 (One) bottle collected as sample, which was seized & level under proper seizure list in presence of witnesses duly signed by them and also arrested the above noted accd. person.

The above noted arrested accd. namely Satrughna Kaibartya (38yrs) S/o Nibaran Kaibortya of Vill- Indtard, PS- Para, District - Purulia committed offence u/s 46 A(c) B.E. Act. 1909 for unauthorized possession and sale of country spirit in his house.

Under the above fact and circumstance I pray that a case u/s 46 A (c) B.E. Act'1909 may kindly be started against Satrughna Kaibartya (38yrs) S/o Nibaran Kaibortya of Vill- Indtard, PS- Para, District - Purulia and arrange for its investigation.
