Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that **MD REJAK ANSARY, S/O- LATE KARMOLI ANSARY of VILL-Bahara, P.S.-Para, Dist-Purulia**, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 24.07.2018 at about 11.15AM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with Mr Bilash Ch.Mahato Gr I TSH of Dubra Para CCC and Alok Kr Pandey, HG GR-I TSH, Dubra Para CCC inspected the premises of **MD REJAK ANSARY, S/O- LATE KARMOLI ANSARY of VILL-Bahara, P.S.-Para Dist Purulia WSEDCL**. During inspection it was found that the said **MD REJAK ANSARY** was enjoying electricity unauthorizedly by direct tapping of service cable as hooking arrangement from WSEDCL's nearest low tension over head line for running his 04 nos 100 w bulb and 01 no 80W stand fan, 01 no 60 watt ceiling fan , approx load 0.540 KW for Domestic purpose, which is an offence u/s. 135 (1)(a) of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WSEDCL. The inspection team left the site at about 11:30AM.

As such **MD REJAK ANSARY, S/O- LATE KARMOLI ANSARY of VILL-Bahara, P.S.-Para Dist- Purulia** has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
