out of which I Seized the pre cable or core 10 (Ten) meter approx. with hooking device. Seizure list was prepared at the site and accuse person refuse to sign. The inspection team left the site at 04.15 PM on 19.07.2018. The accuse person has committed an offence u/s 135 1(2) of the electricity Act. 2003 subsequently electricity (Amendment) Act 2007.
