I Sri Prashant Kishor, S/O - Kishori Prasad, A.E. & Station Manager of Telkalpara CCC of WBSEDCL do hereby lodge my complaint empowered by the Electricity (Amendment) Act-2007 to the effect that Basiruddin Ansary S/O Lt. Kasem Ansary of Vill - Poadlara, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) as detailed here under.

Today, i.e. on 12.07.2018 I, Prashant Kishor (AE&SM), along with Sri Chinmoy Maity, SAE(E), & Sri Debdulal Banerjee, Sr. TSH of Telkalpara CCC, WBSEDCL conducted a raid programme at village Poadlara under Purulia(M) P.S. When our team at about 11.00 P.M. entered to the Domestic premises of Basiruddin Ansary, we found that he was enjoying electricity dishonestly by means of Meter Bypassing by way of tampering service cable and run domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, tampered Service cable dismantled and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 11.30 P.M. after completion of inspection & necessary formalities.

Basiruddin Ansary S/O Lt. Kasem Ansary of Vill - Poadlara, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) of the Electricity (Amendment) Act-2007.
