In producing herewith the accused persons namely Sk.Jabir (30) s/o Sk. Mustakin r/o Hutmura Ps-Purulia(M), Dist Purulia under arrest and seized articles (i) One white coloured Poly sack (BASTA) loaded with 24 Kgs & 900 grams including sack Cannabis/Ganja (2) 03 envelope containing 100 gm each of loose Cannabis/Canja which have been collected from bag as sample & (3) One TVS Racing Apache RTA Black colour motorcycle bearing Reg. No WB 56L4563 shows on the number plate having Engine No. OE6LG2152499, Chassis No. MD634KE67G2L86059 under proper seizure list sealed and level duly signed by the witnesses and accused persons, I SI Tapan Tewary, I/C Tamna O.P under Purulia (M) PS do hereby lodge this complaint suo-motu against the above noted accused person for committing an offence punishable U/S 20 (b)(1)/29 NDPS Act 1985. Today (20.07.18) at 16: 55 hrs. when I along with my accompanying force namely (1) C/111 Samulal Tudu, (ii) C/877 Basudev Mahato & (iii) NVF/ 975 Kalipada Gerain all of Tamna OP under PLA (M) PS with Govt, vehicle WB56C-5423 were performing NAKA CHECKING duty at Changi X-ing More vide Tamna O.P C.C. No. 685/18 dtd. 20.07.18 detained one person namely (1) Sk.Jabir s/o Sk. Mustakin r/o Hutmura PS-Purulia(M), Dist Purulia who was coming from Purulia town side towards TATA by riding a motor cycle and found that he was carrying one white colour poly sack binding on the back side seat of his motor cycle. One being asked he stated that he was carrying said cannabis/Ganja in order to sale in TATA side. Arranged proper guard with the help of my accompanying force and informed the matter to my superiors over my mobile

Thereafter, O/C, Purulia (M) P.S, C.I Sadar Purulia reached on the spot. I issued notice upon the accused person asking him whether he is willing to be searched by me in presence of an Executive Magistrate or a Gazetted Officer. In reply of the notice, detained person gave his willingness in writing to be searched in presence of an Executive Magistrate, accordingly informed to the Sri Dibya Jyoti Das, BDO Purulia-I(Exe. Magistrate) with a request for search and seizure as per provision of section 50 of NDPS Act. After a while two public witnesses namely 1)Sk. Julfikar S/O Sk. Noor Sahid of Tatari, P.S Purulia(M), Dist. Purulia (2) Ganesh Ch. Mahato S/O Late Chakradhar Mahato of village Mohara, P.S- Purulia(M), Dist. Purulia became ready to assist us in conducting search & seizure. At about 18:05 hrs. BDO Purulia-I arrived at the spot and disclosed his identity and explained the reason for arriving there. After his arrival I started search & seizure process at PO. Then I offered the said detained persons to search our persons before get them searched.

Accordingly he conducted search of our persons but nothing was found except our official belongings and accordingly, I prepared NIL seizure list in presence of Sri Dibya Jyoti Das, B.D.O Purulia-I and detained person. At first myself with the help of force searched Sk Jabir and his belonging at the spot. During search of him found One white coloured Poly sack (BASTA) loaded with 24 Kgs & 900 grams including slack Cannabis/Ganja. Thereafter as per direction of BDO Purulia-I, I opened some portion of sack and found Cannabis/Ganja in this sack. Accordingly I seized the said bag under proper seizure list duly signed by the public witnesses, police witnesses and accused person in presence of BDO Purulia-I. Also packaged, sealed and leveled the same at the PO with the help of accompanied force and made over one copy of seizure list to the accused person. I also seized one TVS Racing Apache RTR Black colour motorcycle bearing Reg. No WB 56L4563 shows on the number plate having Engine No. OE6LG2152499, Chassis No. MD634KE67G2L86059 from the possession of rider namely Sk Jabir. The Cannabis/Ganja is prohibited narcotic drugs which he was dealing in lieu of money that violating Sec. 20(b)(i)/29 NDPS Act 1985. There is no question of having any license in respect of possessing the same, accordingly I arrested him. Informed him ground of arrest, prepared memo of arrest and maintained all formalities regarding arrest. Total process of arrest, search, seizure, sealing and leveling were done between 18:15 hrs and 21;35 hrs under direct supervision of BDO Purulia-I and CI Sadar, Purulia with sufficient light.

I pray before you kindly a specific case may kindly be started under proper section of law against arrested accused person namely 1) Sk.Jabir s/o Sk. Mustakin r/o Hutmura PS- Purulia(M), Dist Purulia for its investigation
