and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing
the energy meter i.e. U/S135(1)(b) was detected. The details of passing the arrangement was damage
of installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his
house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Electric Heater - 01 no. 2) Electric Fan - 04 nos. 3) Extractor - 01 no.
- 4) Color TV - 01 no. 5) Water Pump - 01 no. 6) LED - 04 nos.

Out of which I seized the following.

- 1) Tapping arrangement of Service wire - 15' ft. (Arms X).
 - 2) Electric Heater - 01 no. 3) Bulb with holder along with connecting top - 01 no.
- Seizure list was prepared at the site and accused person refuse to sign/sighed. The inspection team left
the premises at 5:10 P.M. on 12.7.18. The accused person has committed an offence
U/S135(1) (a) of the electricity act-2003 subsequently electricity (Amendment) act- 2007.
