I SI, Dipanakar Sarkar, O/C Purulia (T) PS do hereby lodged complaint as Suo-motu against following accused persons (1) Kaberi Chatterjee of Reni road, Purulia & District President, BJP Mahila Morcha, Purulia, (2) Bidyasagar Chakraborty of Anara, PS- Para, Dist- Purulia & District President, BJP, Purulia, (3) Bibek Ranga of BB Das road, Purulia & District General Secretary, BJP, Purulia, (4) Punam Singh of Nadiha Misti Mahal, Purulia (5) Jhuma Goswami of Bankura (6) Biplab Chatterjee of Jaragora, PS- Boro, Dist- Purulia (7) Baneswar Mahato of Balarampur, Purulia, (8) Bandana Hazra, of Santuri, Dist-Purulia, all of BJP and unknown approx 300 unruly followers of BJP comprising of mainly lady (BJP Mahila Morcha) workers & followers to the effect that today (19.07.2018) at about 10:05 hrs, I came to know that, above persons are organizing a procession from Jubilee Maidan, Purulia with a view to Gherao the Office of the Superintendent of Police, Purulia with Brooms (JHANTA), Lathi etc in their hand in support of their scheduled programme, though there was no permission for that programme. I left PS to verify the input vide Purulia (T) PS GDE No 1435 dated 19.07.2018. After reaching the spot, it could be observed that, above persons were preparing to start the rally with huge amount of brooms, Lathi etc in their hands. Myself with accompanying officers & force asked them not to conduct their rally and the Gherao programme for maintenance of Law & Order situation at Purulia town, but they did not heed any attention to my word. I repeatedly asked them for not to doing the same, but they did not listen to my words and started their procession by showing those brooms, lathi etc. I informed the fact to my superiors and with my accompanying officers & force tried to resist them for conducting such unlawful procession. But, they became violent and over powering us they continued their unlawful rally. Finding no other way we declared the mob as unlawful assembly and directed them to disperse. But the mob became furious and overpowering us they conducted the rally. At about 13:00 hrs, when they reached near the DM office main gate of Purulia, the police party of Purulia district tried to stop them by placing 'guard rails' on the road. They were again asked to stop and not to proceed towards the SP office. But they became more violent and started to assault police party by brooms, lathi etc. Due to their assault, (1) SI Debasish Bandopadhyay, O/C, Purulia (M) PS, (2) SI Sekhar Mitra, O/C, Kenda PS, (3) LSI Paromita Samaddar, O/C, Purulia Sadar Women PS, (4) LSI Arpita Bhatta, O/C, Raghunathpur Women PS and other police personnel received serious injuries and were shifted to Purulia Sadar Hospital for treatment. They took away one Nokia mobile hand set having SIM No 8145500380 and one Titan wristwatch of SI Debasish Bandopadhyay, O/C, Purulia (M) PS. They also damaged some Govt Guard rails. Finding no other alternative we chased them, when they flee away. We tried to apprehend them, but none could be nabbed. I seized some brooms, Lathi and the damaged Guard-Rail from the PO. Total fact has been recorded under videography.

As such for committing offence punishable U/S 147/148/149/353/186/188/307/506/379 IPC, 3 PDPP Act, I started Purulia (T) PS Case No 92/18 dated 19.07.18 U/S 147/148/149/353/186/188/307/506/379 IPC, 3 PDPP Act against the above noted accused persons (1) Kaberi Chatterjee of Reni road, Purulia & District President, BJP Mahila Morcha, Purulia, (2) Bidyasagar Chakraborty of Anara, PS- Para, Dist- Purulia & District President, BJP, Purulia, (3) Bibek Ranga of BB Das road, Purulia & District General Secretary, BJP, Purulia, (4) Punam Singh of Nadiha Misti Mahal, Purulia (5) Jhuma Goswami of Bankura (6) Biplab Chatterjee of Jaragora, PS- Boro, Dist- Purulia (7) Baneswar Mahato of Balarampur, Purulia, (8) Bandana Hazra, of Santuri, Dist-Purulia, all of BJP and unknown approx 300 unruly followers of BJP comprising of mainly lady (BJP Mahila Morcha) worker & follower of BJP and endorsed SI Subal Goswami of Purulia (T) PS for its investigation.
