No.3, would be solemnised as per Hindu rites, customs & usages as prevails the then society on 01-2-2018, English Calender year . Be it mentioned both would be bride & bridegroom also rendered their consent to that effect.

 Accordingly social relation of two families was also started blosming in their society and locality . Naturally visiting terms in between fwo family were sufficiently grown.
- 4. That on the plea of said relation Accd. No.1had several occasion to come to the house of the complt. Eventually on 01-10.2017 Accd. No.1 also corrowed an amount of Rs.40,000/-from the compltto meet his some domestice requirement under stipulation to repay the amount within 4/5 months of its x receiving.
- from the complt. Accd. No.1came to the complt. on 02/11/2017 in which complt, showed his unability per contra Accd No.1 showed his unwillingness to perform his daughter's marriage on the fixed date and post ponded to 19-4-2018. However your complt and his family also agreed to the said proposal considering him as geunine and bonafide.
- 6. That it is not be out of mention that several arrangements on the part of the complt.and his familyweres progressed

pertaining to the marriage likely to be held on 01-2-2018 but ultimately post ponded as a result complt .had suffered financil loss.

- That on 23-3-2018 in the morning part Accd.No.1 along Accd.
 No.2 came to the house of the complt. in which complt accepted
 them cordially and ex enquired about their so coming without any
 information in which Accd. persons disclosed that they are no
 longer interested to keep any relation with the complt. and his
 son for proposed marriage with Accd.No.3 and witness No.2 as they
 have given marriage of Accd. No.3 with some other few days ago.
 Complt. became spell bound it was nothing but bolt from the blue
 which
 seme left him as broken heart causing servel mental pain & agony.
- 8. That ultimately Accd. persons left the house of the complt. giving threat to face the dire consequence if complt.drag the matter further Accd. also refused to return the loan amount of Rs.40,000/- to the complt.
- 9. That subsequently complete came to know that Accd persons are habituated in doing such illegal & overt acts by causing chaanting with the other previously Accd persons have also cheated some others in same manner.
- 10. That Accd. persons in conspiracy with each other with a view to save, the common purpose have committed the offence as attributable in cheating and breach of trust and involvement of Accd. No.3 cannot be ruled out in the instant case. More over complt has gathred information that prior to 23-3-2018 Accd No.3 has got married with another on 7.10.17 under the ative aid & support of other Accd.person and entire episoder was done in
