In producing herewith one accused person namely Ranjit Kaibartya (37 Yrs.) S/o Late Kalo Kaibartya of Vill.- Natundih, PS – Raghunathpur, Dist.- Purulia under arrest and the following seized articles under seizure list enclosed herewith: -

- 1) 20 (Twenty) sealed bottles (CS) containing 600 ml each and labeled with Dilse.
- 2) One plastic bag.

I do hereby lodge this complaint regarding that today 22.07.18 at about 19:25 hrs during my special mobile duty received source information over telephone that the above noted accused person has been selling liquor illegally & clandestinely of his hotel styled as Ranjit Hotel at Natundih More beside Purulia - Barakar pitch Road. On receiving the reliable source information I communicated with O/C Raghunathpur PS over telephone and as per his instruction I along with C/732 Gopal Das, C/06 Debdas Mukherjee rushed to the spot to work out the information. On arriving to his hotel styled as Ranjit Hotel at Natundih More beside Purulia - Barakar pitch Road at 19:55 hrs. I apprehended the above noted person after a strong attempt and 03 (three) customers seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as above mentioned. I asked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper/document in support for selling such liquor. Accordingly I seized all those noted in the above after preparing proper seizure list and labeled duly signed by the accused person and accompanying party. After this I arrested that accused person namely Ranjit Kaibartya (37 Yrs.) S/o Late Kalo Kaibartya of Vill.- Natundih, PS - Raghunathpur, Dist.-Purulia after maintaining all formalities of arrest.

Under the above facts & circumstances, I pray before your honour that a specific case may kindly be started against the arrested accused person namely Ranjit Kaibartya (37 Yrs.) S/o Late Kalo Kaibartya of Vill.- Natundih, PS – Raghunathpur, Dist.- Purulia under proper section of law and arrange for investigation.
