Sub: Prayer for starting a case U/S 143/149/186/189 IPC and 32 Police Act.

Sir,

With due respect, I, ASI Sambal Singh of Santaldih PS do hereby lodged a sue-motto complaint against 1)Raju Gorain, S/o - Ananda Gorain of Vill. - Kankibazar, 2)Somenath Pandey, S/o - Lt. Bholanath Pandey of Vill. - Poradih, 3) Miten Sahis, S/o - Lt. Bahadur Sahis of Vill. - Shyampur, 4) Biswajit Rajak, S/o - Barani Rajak of Vill. - Bogra 5) Akash Sahababu, S/o - Lt. Kanchan Sahababu of Vill. - Shyampur, all of PS - Santaldih, Dist. - Purulia and 30/40 others, to the effect that On 02/07/18, I along with ASI S.K. Panda, C/709 Samir Kuiry, C/ 500 Shyamsundar Deshmukh, C/768 Ajit Kr. Murmu all of Santalih PS were performing mobile duty at Kanki Bazar under Santaldih PS in uniform with proper decorum (vide Santaldih PS GDE no. 44, dated - 02/07/18 and C.C. no. 2015/18, dated - 02/07/18). At about 11.35hrs. we found that about 35/40 supporters of B.J.P. from different villages were gathered in front of Santaldih PS under the leadership of Raju Gorain, S/o - Ananda Gorain of Kankibazar, PS - Santaldih, Dist. - Purulia. some of them were gathered with lathi, iron-rod etc. We found that all persons gathered in front of Santaldih PS unlawfully assemble in riotous mood and blocked the Paharigora - BCW pitch road and hampering free flow of normal traffic system and agitated against police with a demand to trace out their panchayet Samity member Parimal Mahato immediately and raised their slogan with utmost loud voice and uses filthy languages which was violating the order promulgated by a public servant lawfully empowered.

I alongwith present officers and forces ordered them to free the road as their act obstruct normal traffic flow of Paharigora - BCW pitch road. As they are warned to follow the traffic rules and regulations, the above mentioned persons became very aggressive and threatened police of causing injury. We again persuaded them to lift the blocked but they paid no heed to our request. After few hours, seeing a large number of police personnel with dhal, lathi & helmet the unruly mob lifted the road blocked on Paharigora - BCW pitch road and dispersed from the spot.

On study of the circumstances, the above noted accused persons have virtually committed offence punishable U/S 143/149/186/189 IPC and 32 Police Act.

I, therefore pray to start a case U/S -143/149/186/189 IPC and 32 Police Act against the above noted accd. persons and arrange for its investigation for the sake of justice.
