In producing here with one Satyaban Ojha (48) , S/O – Sanat Kr. Ojha of Vill. – Deoli, PS – Santaldih , Dist- Purulia along with following seized articles viz-

- 1) 20 Liters(Approx) of country spirit contained in a plastic container.
- 2) 150 grams (Approx) NISHADAL,
- 3) 10 pieces of plastic glass.

I. SI Ajit Kr. Mishra of Santaldih P.S. do here by lodged a complaint against accd. namely Satyaban Ojha (48) , S/O – Sanat Kr. Ojha of Vill. – Deoli, PS – Santaldih , Dist- Purulia to the effect that today (07.07.18) at about 16.45 hrs in course of mobile duty I received a telephonic information from a reliable source that accd. Satyaban Ojha (48) , S/O – Sanat Kr. Ojha of Vill. – Deoli. PS – Santaldih , Dist- Purulia stocked country spirit illegally at his temporary goomty at Paharigora more under Santaldih PS and selling the same to hike price for his personal gain. I informed the matter to I/C Santaldih PS and diarized the matter into G.D.E. vide Santaldih PS GDE no. 249, dt. 07.07.2018 and as per direction of I/C Santaldih PS myself along with C/ 765 Lalmohan Murmu and NVF-781 Paresh Ch Mahato of Santaldih PS rushed to the spot for holding raid by Govt vehicle. At about 17.05 hrs myself along with force reached at Paharigora more under Santaldih PS and held raid in the temporary goomty of Satyaban Ojha (48) , S/O – Sanat Kr. Ojha of Vill. – Deoli, PS – Santaldih , Dist- Purulia and found that Satyaban Ojha was mixing the country spirit, contained in plastic Container, with some intoxicated substance (like white powder) having acrid smell which is likely to cause disability or death to human being, at his temporary goomty at Paharigora more under Santaldih PS and seeing the police party liquor customer fled away but police party anyhow managed to apprehend accd Satyaban Ojha and detained him. I asked him about the white powder like substance and accordingly, detained Satyaban Ojha recognized it as "NISHADAL"(approx 150gms contained in a plastic) an intoxicated substance having acrid smell which is likely to cause disability or death to human being. So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles in between 17.45hrs and 18.15hrs after preparing proper seizure list duly sign by accd person and available witnesses and also sealed and labeled the same.
