In producing here with one Bidhan Singh (49) , S/O – Nagendranath Singh of Vill. – Singhbasti, PS – Santaldih , Dist- Purulia along with following seized articles viz-

- 1) 32 Liters(Approx) of country spirit contained in a pollethene zericanes .
- 2) 20 pieces of pouch packets containing small quantity of ID liquor for retail sale,
- 3) One 600ML ID liquor contains bottle taken as sample from the seized article one and mark as exhibit "A".

I, ASI Soumen Kr. Panda of Santaldih P.S. do here by lodged a complaint against aced. namely Bidhan Singh (49) , S/O – Lt. Nagendranath Singh of Vill. – Singhbasti, PS – Santaldih , Dist- Purulia to the effect that today (07.07.18) at about 18.05 hrs in course of mobile duty I received an information from a reliable source that aced. Bidhan Singh (49) , S/O – Nagendranath Singh of Vill. – Singhbasti, PS – Santaldih , Dist- Purulia had stored huge quantity of country spirit illegally at his shop at Singhbasti under Santaldih PS. I informed the matter to I/C Santaldih PS and diarized the matter into G.D.E. vide Santaldih PS GDE no. 245 , dt. 07.07.2018 and as per direction of I/C Santaldih PS myself along with C/ 321 Tulsi Das Roy and C/1110 Hrishikesh Jana of Santaldih PS rushed to the spot for holding raid by Govt vehicle.

At about 18.55 hrs myself along with force reached at Singhbasti under-Santaldih PS and held raid in the shop of Bidhan Singh (49) , S/O – Nagendranath Singh of Vill. – Singhbasti, PS – Santaldih , Dist- Purulia and found Bidhan Singh. We disclosed our identity and the fact of information received from reliable source. I requested him to be witnesses during raid and search and seizure and he agree. Being accompanied by the witnesses, we reached at the shop of above noted person. On seeing police some persons fled away from the shop of above noted person but we managed to apprehend the country spirit seller with the above noted articles which is found preparing pouch packets for retail sale.

I, search the shop, maintaining all legal formalities and recovered the above noted articles. On interrogation he admitted that he had store the above noted quantity of ID liquor in his shop for illegal sale. He also admitted that he is well aware that spurious quantity of ID liquor is noxious and unfit for human consumption, which may harmful to human being ever cause to death. On demand the above noted person could not produce any valid license in respect of recover articles. So, I seized the above noted articles in between 19:25hrs and 20:05 hrs, dtd. – 07.07.18 and arrested him after maintaining all legal formalities as he violated the provision of section 46AA of Bengal Excise (Amendment) Act, 2012.

Hence I therefore pray that a specific case may kindly be started under proper section of law against arrested aced. Bidhan Singh (49) , S/O – Nagendranath Singh of Vill. – Singhbasti, PS – Santaldih , Dist- Purulia and arrange for its investigation.
