Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that **MIRALAL RAJOWAR** S/O- LATE DUARI RAJOWAR of VILL-Paharigora, P.S.-Santaldih,, Dist-Purulia, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 24.07.2018 at about 10.05AM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C along with Mr Bilash Mahato Gr 1 TSM of Dubra Para CCC and Alok Kr Pandey,HG GR-I TSM, Dubra Para CCC inspected the premises of **MIRALAL RAJOWAR**, S/O- LATE DUARI RAJOWAR of VILL-Paharigora, P.S.-Santaldih, Dist Purulia, WBSEDCL. During inspection it was found that the said **MIRALAL RAJOWAR** was enjoying electricity unauthorizedly by direct tapping of service cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 01 no 100 w bulb and 01 no 10W CFL,approx load 0.110 KW for Commercial purpose, which is an offence u/s. 135 (1)(a) of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 10:20AM.

As such **MIRALAL RAJOWAR**, S/O- LATE DUARI RAJOWAR of VILL-Paharigora, P.S.- Santaldih, Dist- Purulia has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
