In producing here with arrested accused persons namely (1) Gobinda Dey (23 yrs) S/O-Mangal@ Sir. Shankar Dey of Vill-Bhagabandh Basti, PS-Para, Dist-Purulia (2) Manish Kumar Srivastaba (24 yrs) S/O-Sri Mahindar Srivastava of Mango Daighutu, PS-Mango, Dist-East Singbhum (Jharkhand) (3) Alok Kr. Sharma (24 yrs) S/O-Sri Ramn Naresh Sharma of Sankasai 05 road, PS-Ulidih, Dist-East Singbhum(Jharkhand) (4) Bijoy Munda (20 yrs) S/O-Lt. Narayan Munda, Surya Para, PS-Medinipur Kotwali, Dist-Paschim Medinipur (5) Rohit(20 yrs) @Totla@Tipu Sultan Kr. Gupta S/O-Shambhu Prasad Gupta of Mango Daighutu, PS-Mango, Dist-East Singbhum (Jharkhand) along with seized one improvised country made iron made Pistol loaded with 05 rounds ammunition in a magazine, two improvised country made iron made One Shooter fire arms, 06 rounds 8mm ammunition, one BHOJALIi, one Knife, one Crowbar, one white colour Tata Sumo vehicle (without number plate) and others, I beg to lodge this complaint against the said arrested accused persons to the effect that today I along with ASI(A/B)-104 Bapi Pal and force (C/519 Baidyanath Murmu, C/557Ambuj Kr. Mondal, C/330 Banamali Saren, JC 1061 Debasish Mondal) were performing Naka duty at Poradiha More on Madhukunda-Saltora pitch road from 20:00 hrs as per schedule which refers to Santuri P.S. C.C. No. 2174/18 Dtd: 01.07.18 & Santuri P.S. GDE No. 29/18 Dtd: 01.07.18. Then at about 22:05 hrs, O/C of Santuri P.S. informed me over telephone that he received a credible source information that a gang of dacoits are coming through a white colour Tata Sumo (without number plate) having black coloured glass from Saltora side to towards Madhukunda side with high speed and on the way they are preparing themselves for committing a dacoity at Indian Oil petrol pump at Jagannathdi.

Accordingly, I briefed my accompany officer & force properly and take position placing road barriers on the road. Few minutes later at about 22:25 hrs, we came to see that a white colour Tata Sumo (without number plate) is coming with high speed. Then, we signaled the said vehicle in uniform to stop. Seeing the police party, firstly the driver tried to cross the Naka party without stopping the vehicle but failed due to placed road barriers. Then, he tried to run reverse using back gear. But, he failed again as we placed road barriers in the mean time at the back side of the vehicle also. Finding no alternative way, all of a sudden tried to flee away from the vehicle. But, we succeed to apprehend all of them (five criminals) after a hot chase. As such there is no locality nearby; we failed to bring any public witness in the night

Then, I interrogate them one by one where they disclosed their identity as noted above and also confessed that they were really being assembled in the said vehicle, preparing themselves on the way with a view to commit dacoity at the said Petrol Pump being armed with Fire Arms and other offensive weapons. Accordingly, I arrest them after prepared proper arrest memo and after observed all the rules & norms of arrest. Then, we started to search each criminal one by one and recovered the following offensive articles from their exclusive and respective possessions as described below:-

- i. One improvised country made iron made .32 bore Pistol with a magazine loaded with 05 (five) rounds ammunition fitted with Butt, Body, Barrel, Trigger, Firing Pin, having overall length of approx 17 cm and length of barrel approx 10 cm which recovered & seized from the exclusive possession of accused Gobinda Dey found kept conceal inside the pant at waist position.
- ii. One improvised iron made country made fire arms fitted with Butt, Body, Barrel, Trigger, Firing Pin, having overall length of approx 22.2, Butt to Body 13.9 cm (approx) and Barrel 12.7 cm(approx) which recovered & seized from the exclusive possession of accused Manish Kumar Srivastaba found kept conceal inside the pant at waist position.
- iii. One improvised iron made country made fire arms fitted with Butt, Body, Barrel, Trigger, Firing Pin, having overall length of approx 22.8 cm, Butt to Body 13.8 cm (approx) and Barrel 12.6 cm(approx)

which recovered & seized from the exclusive possession of accused Alok Kr. Sharma found kept conceal inside the pant at waist position.

iv. 06 (Six) rounds 8 mm cartridge has been recovered and seized from pant's pockets of Manish Kumar Srivastaba and Alok Kr. Sharma respectively 03 rounds each...

- v. One "BHOJALI" with wooden handgrip having approx 42 cm length and covered with a black coloured plastic cover having approx 36 cm length which recovered & seized from the exclusive possession of accused Bijoy Munda kept conceal inside the pant at waist position.
- v. One knife having approx 30 cm length which recovered & seized from the exclusive possession of accused Rohit(@Totla@Tipu Sultan Kr. Gupta which recovered & seized from the exclusive possession of accused ound kept conceal inside the pant at waist position.

Lastly, I searched the vehicle and found - i) one crowbar having 104 cm length, ii) one (01) empty bottle of Foreign Liquor brand of "ROYAL STAG", iii) one packet cigarettes(WILIS FLAKE), iv) two packet of safety matches, v) four plastic glass and vi) one Chanachur packet.

All the above noted articles have been seized including white colour Tata Sumo (without number plate) having Engine No. 253401148208 and Chassis No. 446229J9E04466 under proper seizure list duly signed by the witnesses and accused persons. The process of search, arrest and seizure commenced at 23:25 hrs and completed at 23:55 hrs.

I like to note here that during arrest all the arrested accused persons were well informed regarding cause of arrest, copies of arrest memo & seizure list has been supplied to them.

The above noted arrested accused persons and their associates were came there with unauthorized improvised fire arms, one BHOJALI, one Knife, one Crowbar, for committing dacoity at "Jaganathdi Indian Oil Petrol Pump" and they are liable U/S 399/402 I.P.C. read with sec. 25(1-A)/27/35 Arms act.

So, kindly start a case against all the 05 (Five) arrested accused persons namely (1) Gobinda Dey (23 yrs) S/O-Mangal@ Shankar Dey of Vill-Bhagabandh Basti, PS-Para, Dist-Purulia (2) Manish Kumar Srivastaba (24 yrs) S/O-Sri Mahindar Srivastava of Mango Daighutu, PS-Mango, Dist-East Singbhum (Jharkhand) (3) Alok Kr. Sharma (24 yrs) S/O-Sri Ramn Naresh Sharma of Sankasai 05 road, PS-Ulidih, Dist-East Singbhum(Jharkhand) (4) Bijoy Munda (20 yrs) S/O-Lt. Narayan Munda, Surya Para, PS-Medinipur Kotwali, Dist-Paschim Medinipur (5) Rohit(20 yrs) @Totla@Tipu Sultan Kr. Gupta S/0-Shambhu Gupta of Mango Daighutu, PS-Mango, Dist-East Singbhum(Jharkhand) and arrange its investigation.
