I do hereby lodge complaint empowered by enabling The Electricity Act-2003, subsequently Electricity (Amendment) Act-2007 to the effect that I.S.War. Hembram 510-Lt. Budhurai Hembram, Vill. Entered the premises of I.S.War. Hembram, 510-Lt. Budhurai Hembram Vill. Uparikh (Santal Para), P.O- Sunuri, P.P- Santuri, Dist- Purulia,

and inspected his/her premises. During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of W.B.S.E.D.C.L. i.e. U/S 135 (I) (a) was detected.

From the above arrangement he/she was using the following electrical equipments
