I do hereby lodge complaint empowered by enabling The Electricity Act-2003, subsequently Electricity (Amendment) Act-2007 to the effect that Shree Nath Bhattacharya s/o Lt Mangolmoy Bhattacharya St V.U+Po - Pachandapur, PS-Santuri, Dist - Purulia

has committed theft of electricity U/S 135 of The Electricity (amendment Act-2007).

Entered the premises of Shree Nath Bhattacharya, s/o Lt Mangolmoy Bhattacharya St V.U+Po - Pachandapur, PS-Santuri, Dist - Purulia

and inspected his/her premises. During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the ^{nearest} L.T.O.H line of W.B.S.E.D.C.L. i.e. U/S 135 (I) (a) was detected.

From the above arrangement he/she was using the following electrical equipments

- 1) Mixer Grinder (Rishabh Home appliances/Preetmix) - 550 W
- 2) Refridator - 350 W
- 3) Television - 150 W
- 4) Fan (6 nos) - 100W x 6 = 600W
- 5) Bulb (100W) - (5 nos) = 500W
6. LED (4 nos) = (4 x 9W) = 36 watt
7. CFL (2 nos) = (18 x 2) = 36 watt
8. Aqua guard water purifier = 75 W
9. Tube light - 8 nos = (8 x 40) = 320 W.

out of which I seized the following

- 1) LED (1 nos) - 18 W
- 2) CFL (1 nos) - 18 W
- 3) Mixer Grinder (1 nos) (Maker's Name - Preetmix) - Rishabh Home appliance
- 4) Service cable (down perked) (black color)

Seizure list was prepared at the site and accused person refused to sign/signed.

The inspection team left the premises at 5:05 PM on 18/07/2018.

The accused person has committed an offence U/S 135 (I) (a) of The Electricity Act-2003 & subsequently Electricity (Amendment) Act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
