In producing herewith five arrested accused persons namely 1) Samrat Ghoshal (23) Yrs.) S/O Dilip Ghoshal of Adra Post Office Para, Adra PS- Adra Dist- Purulia 2) Shankar Mahato @ Kunta (28 Yrs.) S/O Jagannath Mahato of Vill- Monipur PS- Adra Dist- Purulia 3) Rabi Toppo (25 Yrs.) S/O Lt. Sudhir Toppo of Vill- Monipur PS- Adra Dist- Purulia 4) Gobinda Ghasi (28 yrs.) S/O Joyraj Ghasi of Vill- Monipur, Near Boys Hostel, PS- Adra Dist- Purulia & 5) Mithun Pakhmara (28 Yrs.) S/O Lt. Raghu Pakhmara of Vill- Monipur PS- Adra Dist- Purulia along with seized articles 1) One 'Screw Driver' having length about 15 inch including Butt 2) One Vojali length about 35 cm. including Butt 3) One "SHAVAL" having length about 2 feet 4) One Torch Light and 5) One Iron rod length about 4 feet under proper seizure list to the effect that on 13.08.2018 at 00:45 hrs received a credible source information that 8/9 miscreants are assembling at a open filed behind bush beside Arrah GP Office and preparing to commit dacoity at Barabagan village under Adra PS area. I diarised the fact vide Adra PS GDE No 475 dated. 13.08.2018 and I informed the matter to O/C Adra PS and as per order of O/C Adra PS myself along with 1) ASI Giridhari Roy 2) JC-411 Pinku Saha 3) JC/572 Ajoy Giri 4) JC/1175 Ratna Kamal Saha 5) RJC/1539 Nimai Mahato 6) RJC/1480 Prasanta Sahis & 7) RJC/1570 Nitesh Shaw all of Adra PS wearing full uniform left for Arrah GP Office under Adra P.S. to work out the information. On reaching near Arrah GP Office we stopped our vehicle at a distance place as guided by the source and proceeded towards the anticipatory place and we noticed that some persons were sitting/ assembled surrounding each other. We silently proceeded nearer to them and heard that they were planning in between each and other for committing dacoity in a house of Barabagan village. Accordingly, we cordoned them and I shouted in a loud voice disclosing our identity and asked them to surrender before us. In the mean time, the assembled miscreants tried to flee away from the spot but we managed to apprehend above noted five miscreants but one Rajesh Ghasi of Monipur village and 2/3 persons managed to escape despite hot chase which was seen by dragon light those were with us. On being asked, they failed to give any satisfactory reply in respect of their presence at there in such dead hours of late night. In course of thorough interrogation they disclosed their particulars as noted above. In course of searching individually, I found one 'Screw Driver' having length about 15 inch including Butt from the waist of accused Samrat Ghoshal and one Vojali length about 35 cm. including Butt from the waist of Shankar Mahato. Thereafter I also searched the place and found one "SHAVAL" having length about 2 feet, one Torch Light and one Iron rod length about 4 feet. On being asked in respect of possessing the offending articles, they failed to give any satisfactory accounts in support of the offending articles. On interrogation they confessed that they were assembling to commit dacoity at the last night at Barabagan village under Adra P.S. I, accordingly, seized & labeled the above noted articles under proper seizure list duly signed by the accused persons and Police personnel as there is no public were present at that time. Hence, I arrested them U/S 399/402 IPC and communicated the reason of arrest and issued memo of arrest.

I on my arrival back to PS along with other officer and force with the arrested accused persons along with seized articles, lodge the complaint against the above noted accused persons

namely 1) Samrat Ghoshal (23 Yrs.) S/O Dilip Ghoshal of Adra Post Office Para, Adra PS- Adra Dist- Purulia 2) Shankar Mahato @ Kunta (28 Yrs.) S/O Jagannath Mahato of Vill- Monipur PS- Adra Dist- Purulia 3) Rabi Toppo (25 Yrs.) S/O Lt. Sudhir Toppo of Vill- Monipur PS- Adra Dist- Purulia 4) Gobinda Ghasi (28 yrs.) S/O Joyraj Ghasi of Vill- Monipur, Near Boys Hostel, PS- Adra Dist- Purulia 5) Mithun Pakhmara (28 Yrs.) S/O Lt. Raghu Pakhmara of Vill- Monipur PS- Adra Dist- Purulia 6) Rajesh Ghasi S/O Joyraj Ghasi of Vill- Monipur, Near Boys Hostel, PS- Adra Dist- Purulia and 2/3 others to start a case under proper section of law and to arrange for its investigation.
