I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Abdul Salam s/o- LT Abdul Rahaman of Village- Lower Thorialih Adra, P.S- Adra, Dist- PURULIA has committed theft of Electricity U/S 135 of the Electricity (Amendment) Act-2007.

Entered the premises of Abdul Salam s/o LT Abdul Rahaman, of Village- Lower Thorialih Adra, P.S- Adra, Dist- Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by bypassing from the incoming service cable before energy meter.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

Fan 3 Nos, Incandescent Bulb 3 Nos, TV, CFL.

Out of which we seized the following:

Some portion of service cable with lapping arrange & meter, 15 amp switch board.

The seizure list is prepared at the site and the accused person signed in the seizer list

The inspection team left the above premises at about 3:55 PM on dated 27/08/2018 The accused person has committed an offence U/S-135(b) of the Electricity (Amendment) Act-2007
