S.I Tarapada Mondal O/C Arsha P.S do hereby lodged complaint as suo-motu against arrested accused persons namely (1) Hiralal Singh (48 Yrs) S/O Lt. Biswanath Singh of Rajpati (2) Suchand Soren (24 yrs) S/O Durjodhan Soren of Mahulard (3) Santanu Mahali (28 Yrs) S/O Hatiram Mahali of Chatuhansa [4] Dipak Majhi @ Lodhar Majhi (23 yrs) S/O Monohar Majhi of Patuara (5) Dakta Mahato @ Bhukru (28 yrs) S/O Sanatan Mahato of Hinduhr all of PS Arsha, Dist Purulia and the other accused persons namely (6) Harekrishna Majhi S/O Lt. Radhanath Majhi of Patuara (7) Rohini Kumar Majhi of Patuara (8) Nakul Ch. Majhi S/o Lt. Sadananda Majhi of Patuara (9) Padma Kishor Majhi S/o- Pashupati (10) Sanjay Dey S/o- Amulya Ratan Dey of Mudali (11) Bahadur Singh S/o- Banku Singh of Rajpati (14) Dulal Majhi S/o- Bhandu Majhi of Nalakocha (15) Binoy Singh S/o- Ashu Singh of Chatuhansa (16) Badrinath Majhi S/o- Anath Majhi of Patuara (17) Manohar Majhi S/o- Budul Majhi of Patuara (18) Jagru Majhi S/o- Probodh Majhi of Patuara (19) Jagru Goral S/o- Sebadas Goral of Patuara (20) Aditya @ Ada Majhi S/o- Saharai Majhi of Patuara who were also present and managed to flee away the out side of Chatuhansa GP and 300 others riotous mob all of PS Arsha, Dist Purulia to the fact that today i.e. on 27.08.18 from 11:00 hrs I along with other officer and force were performing duty in front of Chatuhansa Gram Panchayet in c/w formation of Gram Panchayet Board vide Arsha PS CC No. 2077/18 and CC No. 2080/18 dtd. 27.08.18 After formation of Gram Panchayet at about 15:00 hrs. when the members of BJP came out from Chatuhansa GP after boards Harekrishna Majhi and Jagru Goral of Patuara then the supporters of BJP became furious and were showing agitation against Police and BDO Arsha Block. They were also using filthy language and tried to huddle Police. We tried to convince them but they pay no heed to us. They were obstructing police while discharging Govt. duty. There were a mob more than 400 persons at the spot. The mob was in very riotous mood. Somehow at about 15:45 hrs suddenly the mob became violent and started pelting stone/ bricks bat upon the Police party. We tried to pacify the mob by convincing the matter but the mob became so much violent and started pelting stone, brickbats aiming to us with intention to kill the police personnel and also to damage the the Govt. vehicle. As a result 1) ASI Joydev Atta of Arsha PS 2) C/314 Arup Singh of SAP 7<sup>th</sup> BN camp at Arsha PS 3) JLC/1141 Asima Chatterjee received serious injuries on their person. Mean while they also damaged Govt M/C No. WB 56C/ 0803 which was parked in front of the GP Office. When the situation became grave at about 15:00 hrs I informed the matter to my superiors and requested for re enforcement. At about 16:00 hrs the re enforcement party arrived and before going the situation out of control as well as to save our life and property I declared them as un-lawful assembly and we chased the mob to disperse. In spite of our several reminder the mob did not move from the place and increase the level of brick batting up on the police party. Finding no other alternative with a view to disperse the mob I ordered the police personnel to open fire Grenade gas from Gas Gun. Accordingly 02 (Two) Grenade gas were fired Subsequently , we could be able to apprehend 05 (Five) accused persons from the spot who disclosed their name and address as noted above. The above noted persons were also found in leading line of the agitated mob. On 27.08.18 at 16:00 hrs. to 16:45 hrs. the persons were arrested observing all legal formalities regarding arrest. Also recovered 45 pieces of brickbats, 2 Tangi, 28 pieces of Lathi, 07 iron rod, one bow and arrow were also seized from the PD as well as from the possession of the arrested accused persons. All the item were seized under proper seizure list in between 17:00 hrs and 18:30 hrs. We tried to search for local witnesses but none was willing to put signature on the seizure list.

The injured police persons were medically treated at Sirkabad BPHC. Subsequently one injured C/314 Arup Singh was admitted at Sirkabad BPHC and there after referred to Purulia Sadar Hospital for better management.

As such for committing offence punishable U/S-147/148/149/323/325/308/186/332/333 /353/506/427 IPC & Sec-3 of PDPP Act, started Arsha PS case No-82/18 .Dtd-27.08.18 U/S-147/148/149/323/325/308/186/332/333 /353/506/427 IPC Sec-3 of PDPP Act against the above noted accused persons and 300 others riotous & unruly mob and directed to S.I. Nakul Chandra Ruhidas of Arsha P.S to investigate the case.
