Sub: Prayer for lodge specific case under proper section of law.

In producing herewith one accused person namely Amiya Mahtao (26 Yrs) S/O- Umesh Mahato Vill-Ukada , P.S -Baghmundi , Dist - Purulia along with 1) One red colour without Regn. number Tractor having Eng No.-NHJ5HAE8033 and Chassis No.- MBNSFAEBAHNJ04646 along with red coloured without Regn no trolley loaded with 8 Quintal (approx) Charcoal 2) Two (02) Kg charcoal taken from the main contraband as sample under proper seizure list. I ASI Puspen Ghosh, beg to submit that today on 31/07/18 at 02: 45 hrs when I was performing anti crime night patrolling duty at Pattard village road along with C/275 Bikash Sing, C/683 Yunus Mandal both of Baghmundi PS vide Baghmundi PS CC No -1662 Dtd 31.07.18 and GDE No- 1385 Dtd 31.07.18, found one tractor was coming suspiciously towards Jhalda side from Koreng More, (Baghmundi-Jhalda Road). I along with force tried to stop the tractor but on seeing the police party the driver of the tractor speed up and tried to flee away. After a hot chase I along with force managed to stop the said tractor. On being asked, the driver of the tractor replied that in his tractor's trolley loaded with charcoal. Accordingly I asked him to produce the valid documents, but the driver namely Amiya Mahtao S/O- Umesh Mahato Vill- Ukada, P.S -Baghmundi, Dist - Purulia unable to produce any constitutional document against charcoal and tractor. I informed the matter to O/C Baghmundi PS as per his direction seized (1) One red colored without Regn. number Tractor having Eng No.-NHJ5HAE8033 and Chassis No.- MBNSFAEBAHNJ04646 along with red coloured without Regn. no trolley loaded with 8 Quintals (approx) Charcoal (2) Two (02) Kg charcoal taken from the main contraband as sample in between 03.00 hrs to 03.15 hrs. I seized the all materials in presence of witnesses under proper seizure list though I searched for public witnesses but as it is the dead hours of night, we unable to find any one. In this circumstances, there is sufficient reasons to believe that the said tractor driver/owner of the vehicle and others dishonestly transporting the charcoal with illegal means in the dead hours of night and maintaining a clandestine business of charcoal after hashing up Govt. revenue after hatching up a criminal conspiracy for the propose of wrongful gain through unconstitutional channel being violated the existing Govt. order and showing thumbs towards the Govt. The driver/ owner of the vehicle arrested after maintaining all the guidelines of Apex Court of India, N.H.R.C., and W.B.H.R.C at 03.25 hrs. On being interrogation, the driver Amiya Mahtao stated that he along with his father Umesh Mahato S/O - Lt. Hariram Mahato is running this clandestine business since long showing thumb to the Administration after hatching up a criminal conspiracy and sell this charcoal at Jhalda area. As the driver/owner of the tractor committed offence U/S-379/413/414/188/120B IPC. So a specific case may kindly be started against the driver/ owner 1)Amiya Mahtao(26 Yrs) S/O- Umesh Mahato 2) Umesh Mahato S/O - Lt. Hariram Mahato both of Vill- Ukada, P.S -Baghmundi , Dist - Purulia and others, arrange for its investigation. Be it noted that due to nonavailability of supporting logistic the seized charcoal could not be weighted properly but as stated by the driver approx 08 Quintals Charcoal was loaded.
