I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Gopal Mandal S/O- Sri Matal Mandal of village Jhabri P.G. Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 20/08/18 at about 12.25 PM I Sri Swapan Kumar Das, AE & Station Manager, Bagmundi CCC along with 1. Sri Sukhamoy Maji SAE (E) 2. Abdul Hasib LM 3. — entered the premises of Sri Gopal Mandal S/O- Matal Mandal of village Jhabri P.G. Bagmundi, Dist- Purulia and found Sri Gopal Mandal was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.1 KVA. As Sri Gopal Mandal S/O- Sri Matal Mandal committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sukhamoy Maji SAE (E) 2. Sri Abdul Hasib LM The inspection team left the premises at 12.35 PM.
