Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 20/08/18 at about 12.40 PM I Sri Swapan Kumar Das, AE & Station Manager, Baghmundi CCC along with 1. Sri Sukhamoy Maji SAE(E) 2.
