Sir,

I ASI Sanat Chakraborty S/O- Probodh Kumar Chakraborty of Baghmundi P.S, Dist- Purulia do hereby lodge a complaint against the accused Persons 1) Raju Karmakar (22 Yrs) S/O- Ganesh Karmakar, Vill- Bukadi, P.O.- Burda, P.S.- Baghmundi, Dist- Purulia (Driver of the vehicle), and 2) Bimal Sing, S/O- Lt. Suchand Sing of Vill- Pathardih , P.S.- Baghmundi, Dist- Purulia (Owner of the vehicle) to the effect that today on 29/08/18 at about 15:05 hrs in course of my mobile duty at P.S area received a telephonic information from my source that one tractor was carrying sand illegally from Kudna river, accordingly myself along with force rushed to the spot at Kudna Village and found one Tractor was coming towards Kudna Village. I intercepted the tractor and found that the tractor without Registration No. was tagged with a trolley (without Reg. No.) loaded with sand without any cover. On being asked the driver revealed his identity as Raju Karmakar (22 Yrs) S/O- Ganesh Karmakar, Vill- Bukadi, P.O- Burda, P.S- Baghmundi, and Dist- Purulia and on demand, he failed to produce any document of the vehicle or in respect of the sand. He also confessed that he lifted the sand from Kudna River near Kudna Village which is not registered sand and he lifted sand from the place only to escape from the Govt. revenue by hatching up a criminal conspiracy. Hence he could not produce any challan of the sand or the vehicle .He also failed to produce any identity proof event D/L and there is every ground to believe that he procured the tractor and the trolley either in fraudulent means or by means of theft. On being asked he disclosed the name of the owner of the tractor is Bimal Sing, S/O- Lt. Suchand Sing of Vill- Pathardih , P.S.- Baghmundi, Dist- Purulia, hence I seized the tractor with trolley (without Reg. No.) bearing model no Mahindra 475 DI, without Reg. No, Eng. No. NJNB00037, Chassis No. 006501536A3TE22 being loaded with sand without any cover under proper seizure list duly sign by the witness, also arrested the accused driver and during arrest observed all the formalities regarding arrest as per the guidelines of Apex Court of India, N.H.R.C & W.B.H.R.C. I arrested him for the purpose of proper investigation and to ensure his presence in the Ld. Court as his identity could not be verified. I issued check list. Noted that sand mining/ extraction from any riverbed of Dist- Purulia will remain suspended for the rainy season with effect from 01/07/2018, until further order vide memo No. VI/2816/1(86)(M)/17 Date 29/06/18 of ADM and DL & LRO office Purulia.

It is therefore pray before you to start a specific case U/S 379/411/188/120B IPC read with 177/181/184/190(2)/192/196 of MV Act 1998 & Section 21(4) of the mines and minerals (Regulation & Development) Act 1957 against 1) Raju Karmakar (22 Yrs) S/O- Ganesh Karmakar, Vill- Bukadi, P.O.- Burda, P.S.- Baghmundi, Dist- Purulia (Driver of the vehicle), 2) Bimal Sing, S/O- Lt. Suchand Sing of Vill- Pathardih , P.S.- Baghmundi, Dist- Purulia (Owner of the vehicle) and arrange for its investigation.
