I along with Sri Manab Kumar Maji, SAE, Sri Subhasis Mahato, OE of Balarampur  
CCC and technical persons of M/s. Ajoy Kr. Ghosh (enlisted agency of WBSEDCL)  
inspected the premises of Bibhisan Sing Sardar and held raid.

\* During raid and inspection it was detected that accused Bibhisan Mahato  
is using electricity dishonestly by making direct hooking from the nearby LTOH line  
of WBSEDCL for running 1 No 100 Watts Lamp & 1 No 60 Watts Lamp having connected  
load of 0.16 kw

The local people gathered there witnessed the incident but refused to sign on the seizure list and inspection report.

For this activity of the theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135 (i) (a) of electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
