I Sri Amitam Choudhury, S/O dt. Sajal Kr. Choudhury, D.E & Station Manager of Balarampur CCC WBSEDCL do hereby lodge complaint against Sri Jiban Kr. Mondal S/O Haradhan Mondal resides at vill- Ghatbera, P.O- Ghatbera, P.S.- Balarampur, Dist- Purnia to the effect that received an information that the aforesaid accused person is committing theft of electricity in his residence by way of direct hooking from the nearby LTOH line of WBSEDCL.

Acting upon such information today on 16.8.2018 from 1.30 pm to ~~2.40~~ 2.10 pm, I along with Sri Ramendra Narayan Sinha, S.O, S&LP Unit Purnia Region, Sri Sankar Ch. Mahato, Lineaman, Sri Dayamoy Mahato, TSH S&LP Unit, Purnia Region and other officials of Balarampur CCC, WBSEDCL inspected the premises of Jiban Kr. Mondal and held raid.

During raid and inspection it was detected that accused Jiban Kr. Mondal is using electricity dishonestly by making direct hooking from the nearby LTOH line of WBSEDCL for running 1 NO Lamp, 6 Nos 9 watts LED, 1 NO Fridge, 4 Nos Ceiling Fan, 1 NO TV and 1 NO 1/2 H.P. Pump having connected load of 1.079 kW.

I prepared inspection report in presence of the accused person and assessed the load as 1.079 kW details have been mentioned in the inspection report, duly signed by the accused.

I prepared seizure list in presence of witnesses details of seizure have been mentioned in the seizure list duly signed by the accused. A copy of seizure list was handed over to the accused. The local people gathered there witnessed the incident but refused to sign on the seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of Revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135(i) (a) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
