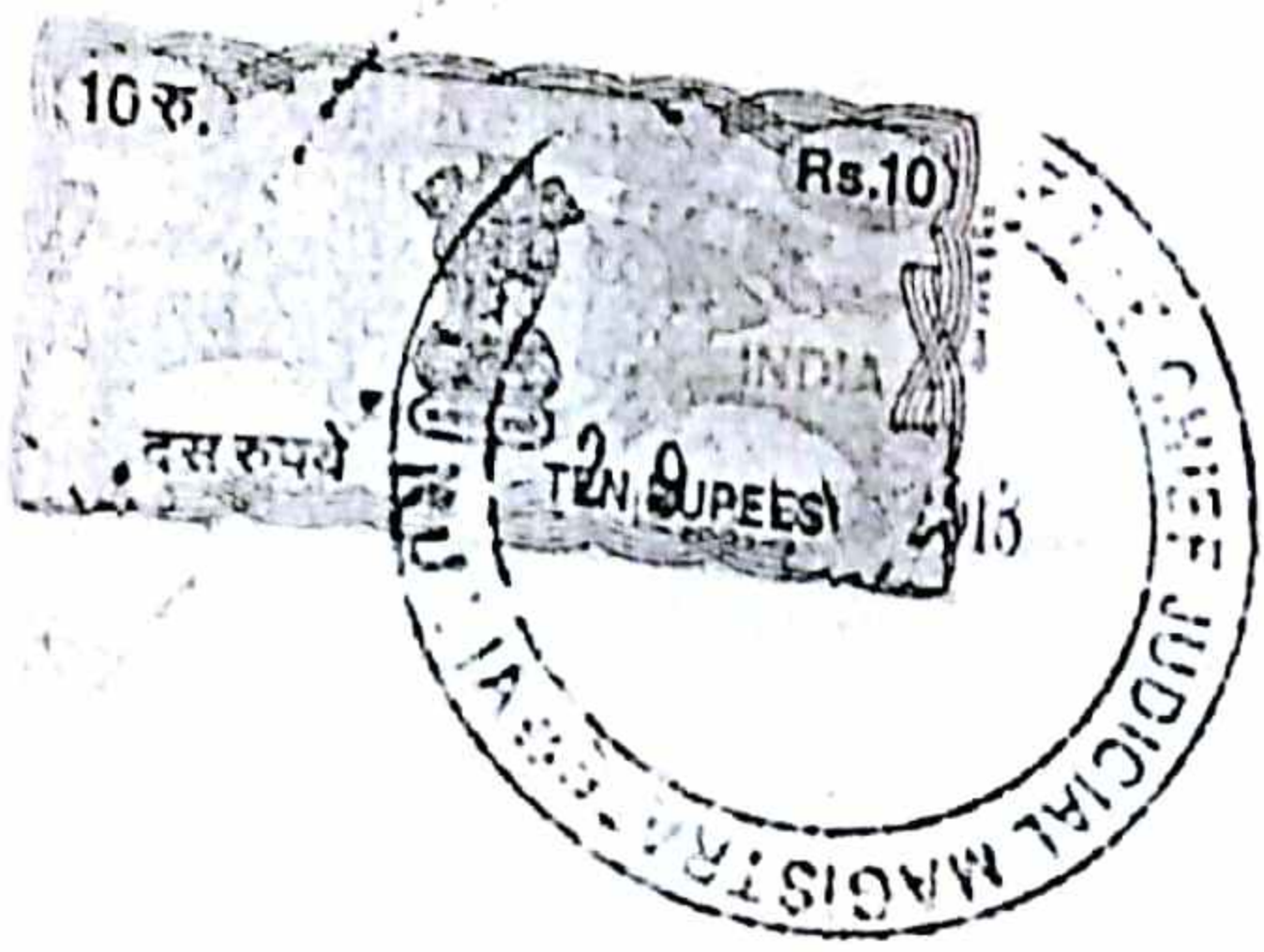

- 1...That the Complainant and the accused persons are the resident of Village Mangla, under P.S. Bandwan, District Purulia and they are well know to each other since long.
- 2...That accused no.1 Shankar Majhi agreed to sale out his property and the complainant after due Nagotiation paid Rs.1,53,712/- (Rupees One lakh fifty three thousand seven hundred twelve) to the accused no.1 as earnest moeny and that there was an written agreement was in the name of Dhani Hembram who is none else but the wife of the complainant and witness: no.2 in this complain.
- 3...That thereafter the complainant several dates requested the accused no.1 to execute and register the sale deed in question in favour of Dhani Hembram.

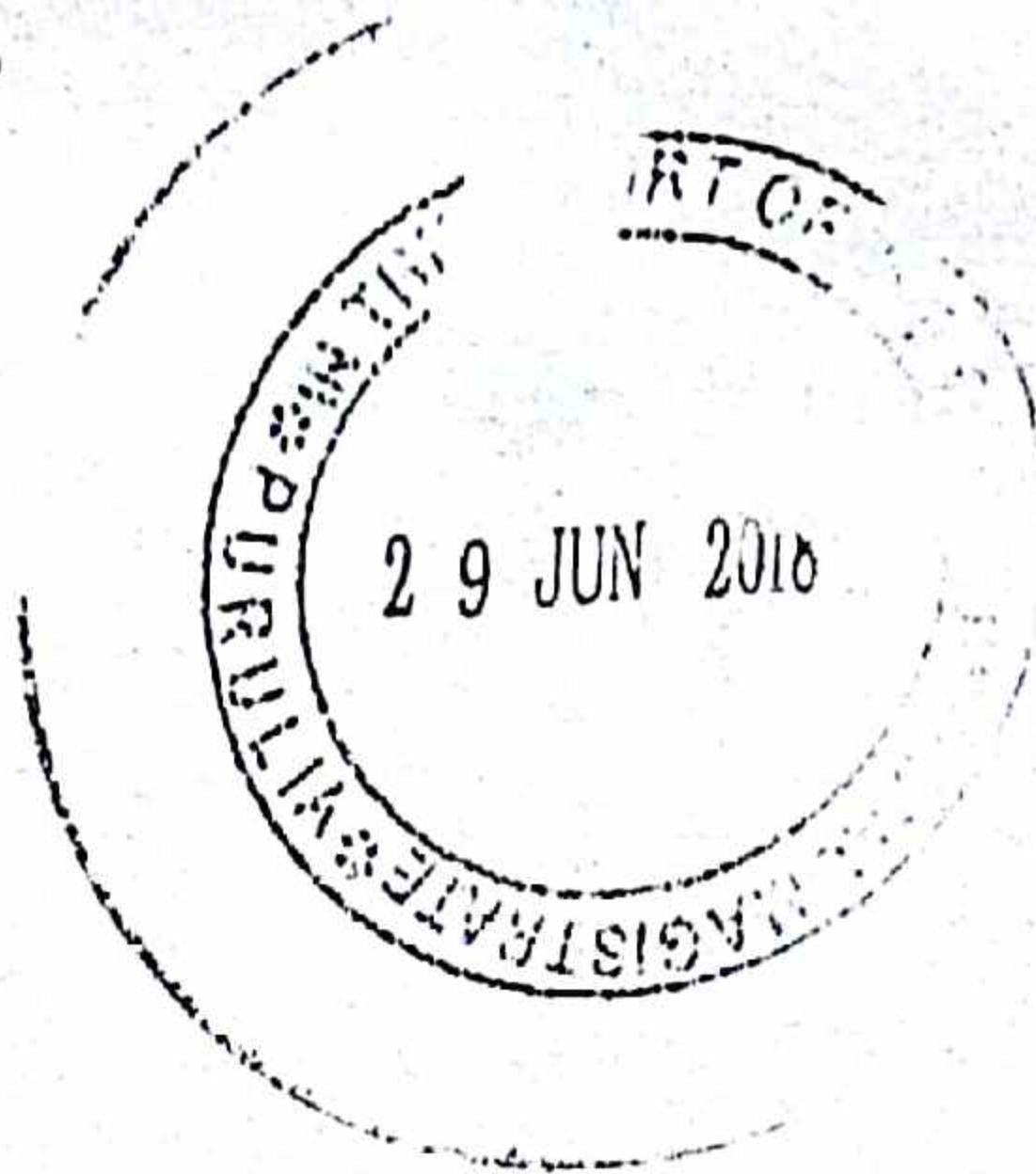
after taking the balance amount .But when the said accused was very reluctant and avoided to execute the sale deed than the Dhani Hembram has filed one Title Suit against the accused person for the sale deed under Specific Performance of Contract act.

4...That since date of said agreement i.e.on 16.3.2017. the complainant is possessing the schedule property and he also construction residential house and his residing therein with his family members.

5...That the accused persons after receiving the summons of the said Title Suit became very much aggressive and became hostile to the complainant and his family members.

6...That on the date of incident i.e.on 19.3.2018 the complainant and his family members had been to their old bastu for offering puja of their family deity. When they return back to their house to their utter surprise show that all the accused persons armed with various deadly weapons criminally trespassed in to the house of the complainant demolish the house in a very inhuman manner causing loss of Rs.50,000/- and also have taken

away hard cash, utensils, wearing appears some ornaments and other valuable articles of the family and total value of would be Rs.1,00,000/- (Rupees one lakh) approximately.

6...That seeing such incident the complainant and others raised alarmed when the local people as well as witnesses collected there men the accused persons are fled away.

7...That when the complainant tried to resist the accused persons than they showed weapons aiming out that they (accused persons) will not hesitated to finish whole family of the complainant in case of their protest.

8.. That it is very pertinent to point out that the accused persons who are very dangerous men in the locality and they with the particular political party have committed such illegal acts upon the complainant and his family members who belongs from tribal family.

8..That the incident was duly informant to the local P.S. by writing when the police had taken a very partitioned

very partitioned attituded being influenced by the accused person and the police under threats to the complainant compelled him to put his signature upon so many blank papers /while papers which perhaps used by the accused persons for their own benefits and that against the complainant.

On request of the complainant police however handed over Xerox copy to the complainant where from the complainant learnt that the accused persons would return him back to Rs.1,70,379/- (Rupees One lakh seventy thousand three thousand seventy nine) within a very short span of time .But that version is/was not the willful person of the accused persons .The complainant is ~~very~~ ready to purchase the property but the accused persons ~~kn~~ with the help of political party and police is always inhumiliate and harras the complainant for which the complainant has been defamed.

9..That as the police did not have taken necessary legal action against the complainant lodged one complaint before the superintendent of police but with same fate.
