I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act-2007 , to the effect that Shri CHITTARANJAN DAS, CON ID-242236386, OF VILL-SERKHADIH, P.S- BARABAZAR, DIST- PURULIA, was enjoying electricity illegally by by-passing the Single Phase Energy Meter (SI No- G154225) From its incoming Service Cable through 2-Core PVC cable and he has committed theft of electricity U/S 135(1)/b of the electricity (Amendment act-2007).

On 09.08.2018 I, Sri ANSHUMAN MITRA, A.E & S.M., BARABAZAR CCC along with

- (1) Saheb Sutradhar, SAE(E), Barabazar CCC, WBSEDCL
- (2) Soumyajit Pramanik, O.E, Barabazar CCC, WBSEDCL

Entered into the premises of CHITTARANJAN DAS, CON ID-242236386, OF VILL-SERKHADIH, P.S- BARABAZAR, DIST- PURULIA , and inspected his premises at 06:10 p.m.

During inspection, it was found that CHITTARANJAN DAS, CON ID-242236386, OF VILL-SERKHADIH, P.S- BARABAZAR, DIST- PURULIA, was enjoying electricity at his premises illegally by by-passing the Single Phase Energy Meter From its incoming Service Cable through 2-Core PVC cable in his premises with connected load of 0.165 KVA.

From the above arrangement he was using the following equipment:

01. 1 no Electric Bulb (60 watt)
02. 1 no of Ceiling Fan (80 watt)

Out of which I seized the following articles:

1. 1 no of single phase Energy Meter (SI No- G154225) with By-passing arrangement.

Seizure list was prepared at site and accused person refused to sign. After process of inspection and seizure list we left the premises at about 6:35 p.m.
