Sub: Complaint U/S- 46(A)(c) The Bengal Excise Act against Chanda Murmu (51) S/o Lt. Monu Murmu of Murgaboni, PS-Barabazar, Dist-Purulia to start a specific case.

Sir,

In producing here with one Chanda Murmu (51) S/o Lt. Monu Murmu of Murgaboni, PS-Barabazar, Dist- Purulia under arrest with one rubber Tube of Truck/Bus which ever may be containing approx 35 (Thirty Five) litters of I.D liquor from which 500 ml I.D liquor taken out as sample under proper seizure list.

I, SI Hemanta Kumar Sahababu of Barabazar PS do here by lodge this complaint as suo-moto against Chanda Murmu (51) S/o Lt. Monu Murmu of Murgaboni, PS-Barabazar, Dist- Purulia that in course of Day Mobile Duty today (26.08,2018) at noon received a source information that one person is unauthorized selling I.D liquor at his home Murgaboni village. Accordingly, I informed the matter to the LC Barabazar PS over Mobile and I have been instructed to verify and work out the credibility of that information. Hence, myself along with C/1130 Asik Ansary & C/1147 Bappaditya Nandi of Barabazar PS with PS vehicle having No- WB- 56C-0014 moved for Murgaboni Village to work out the information. After arriving at the house of Chanda Murmu (52) S/o Lt. Monu Murmu of Murgaboni, PS-Barabazar, Dist- Purulin and it is seen & found that one person was selling I.D. liquor to the customer for wrong full gain. On seeing the Police party the seller and customer had made a deliberate attempt to fled-away but we managed to apprehend the seller Chanda Murmu (51) S/o Lt. Monu Murmu of Murgaboni, PS-Barabazar, Dist- Purulia. On being asked he disclosed his identity as stated above and he failed to produce any valid documents in respect of selling of LD liquor. In course of searching there is found that one rubber made tube of Bus/Truck which ever may be containing approx 35 Ltrs. I.D liquor is lying under the wooden cot in his house. Hence, I seized one rubber made tube of Bus/Truck which ever may be containing approx 35 Ltrs. I.D liquor from his possession and 500 M.L.ID liquor is taken out as sample from the said tube containing 35 Ltrs under proper seizure list which is also duly labeled and also took signature of the disinterested witness of the locality on the seizer list and label. The Seizure was made from 13.45 hrs to 14.25 hrs. There is reasonable ground to belief that the aforesaid person was selling the I.D liquor unauthorizedly for wrong full gain. Thereafter, on 26.08.2018 at 14.35 hrs I secured arrest of said Chanda Murmu (51) S/o Lt. Monu Murmu of Murgaboni. PS-Barabazar, Dist Purulia after preparing Memo of arrest & after observing all other formalities of arrest. I informed him the ground of arrest and also informed his relatives duly signed by him.

Under the above circumstances I, therefore, pray that a specific Case U/S- 46 (A)(c) of The Bengal Excise Act may kindly be registered against said Chanda Murmu (51) S/o Lt. Monu Murmu of Murgaboni, PS-Barabazar, Dist- Purulia and also for arranging its investigation.
