Sub: Complaint U/S- 46(A)(c) The Bengal Excise Act against Sukumar Baskey (24 Yrs) S/o-Suchand Baskey of Village- Murgaboni, PS- Barabazar, Dist- Purulia to start a specific case.

Sir,

In producing here with one Sukumar Baskey (24 Yrs) S/o- Suchand Baskey of Village-Murgaboni, PS- Barabazar, Dist- Purulia under arrest and the one Tube of Truck containing approx 23 (Twenty Three) litters of I.D liquor from which 500 ml I.D liquor taken out as sample under proper seizure list which is attached herewith.

I, ASI Gnan Sankar Pati of Barabazar PS do here by lodge this complaint as suo-moto against Sukumar Baskey (24 Yrs) S/o- Suchand Baskey of Village- Murgaboni, PS- Barabazar, Dist- Purulia that in course of Day Mobile Duty today (19.08.2018) at noon received a source information that one person is unauthorized manufacturing for selling of I.D liquor. Accordingly, I informed the matter to the I.C Barabazar PS over Mobile and I have been instructed to verified and work out the credibility of that information. Hence, myself along with C/- 942 Dipak Mukherjee & C/- 1147 Bappaditya Nandi of Barabazar PS with PS vehicle having No- WB- 26K-5475 moved for Murgaboni Village to work out the information. Two disinterested local people namely 1) Hemanta Hembram 2) Guntha Hembram agreed to accompany us during raid & seizure. After arriving at river side of Murgaboni village and held raid. During raid it is seen & found that 150 litters (Approx) molasses was laying there for manufacturing I.D liquor and one person was manufacturing for selling I.D liquor. 150 litters (Approx) molasses is Seized and destroyed on the spot. On seeing the Police party one person had made a deliberate attempt to fled-away but failed as we had taken care of in all side and managed to apprehend him. In course of searching one tube of Truck containing approx 23 (Twenty Three) litters I.D liquor is found from the possession of said person who was trying to escape from the spot. On being asked he disclosed his identity as Sukumar Baskey (24 Yrs) S/o- Suchand Baskey of Village- Murgaboni, PS- Barabazar, Dist- Purulia. He also failed to produce any valid documents in respect of manufacturing for selling of I.D liquor. So I seized one tube of Truck containing approx 23 (Twenty Three) litters I.D liquor under proper Seizure List and taken 500 ml I.D liquor as sample from that seized I.D liquor which was also duly labeled and also took signature of the local & Police witness on the seizer list and label. The Seizure was made from 14.45 hrs to 15.25 hrs. There is reasonable ground to belief that the aforesaid person was manufacturing for selling the I.D liquor un authorizedly for wrong full gain. Thereafter, on 19.08.2018 at 15.45 hrs I secured arrest of said Sukumar Baskey (24 Yrs) S/o- Suchand Baskey of Village- Murgaboni, PS- Barabazar, Dist- Purulia after preparing Memo of arrest & after observing all other formalities of arrest. I informed him the ground of arrest and also informed his relatives duly signed by him.

Under the above circumstances I, therefore, pray that a specific Case U/S- 46 (A)(c) of The Bengal Excise Act may kindly be registered against said Sukumar Baskey (24 Yrs) S/o- Suchand Baskey of Village- Murgaboni, PS- Barabazar, Dist- Purulia and also for arranging its investigation.
