Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that Shri BAIDYANATH MUDI, S/O- AGHNU MUDI, VILL-LAKA, P.S- BARABAZAR, DIST- PURULIA was enjoying electricity unauthorizedly by direct hooking from nearest LT OH line through 2-Core PVC cable and he has committed theft of electricity U/S 135(1)/a of the electricity (Amendment act-2007).

On 28.08.2018 I, Sri ANSHUMAN MITRA, A.E & S.M., BARABAZAR CCC along with

- (1) Sahab Sutradhar, SAE(E), Barabazar CCC, WBSEDCL
- (2) Soumyajit Pramanik, O.E, Barabazar CCC, WBSEDCL

Entered into the premises of BAIDYANATH MUDI, S/O- AGHNU MUDI, VILL-LAKA, P.S- BARABAZAR, DIST- PURULIA and inspected his premises at 05:10 p.m.

During inspection, it was found that BAIDYANATH MUDI, S/O- AGHNU MUDI, VILL-LAKA, P.S- BARABAZAR, DIST- PURULIA was enjoying electricity illegally by direct hooking from nearest LT OH line through 2-Core PVC cable in his premises at LAKA with connected load of 0.071 KVA.

From the above arrangement he was using the following equipment:

01. 01 no Electric Bulb (60 watt)

Out of which I seized the following articles:

1. 1 no of PVC Cable (8 mtr. Approx) with hooking device.
2. 1 no Electric Bulb (60 watt).

Seizure list was prepared at site and accused person refused to sign. After process of inspection and seizure list we left the premises at about 05:25p.m.

The said person has committed an offence U/S 135(1)/a of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
