I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act- 2007 , to the effect that Shri KIRITI MAHATO, S/O- UMESH MAHATO, VILL-BISHKUDRA, P.S- BARABAZAR, DIST- PURULIA was enjoying electricity unauthorizedly by direct hooking from nearest LT OH line through 2-Core PVC cable and he has committed theft of electricity U/S 135(1)/a of the electricity (Amendment act-2007).

On 28.08.2018 I, Sri ANSHUMAN MITRA, A.E & S.M., BARABAZAR CCC along with

- (1) Saheb Sutradhar, SAE(E), Barabazar CCC, WBSEDCL
- (2) Soumyajit Pramanik, O.E, Barabazar CCC, WBSEDCL

Entered into the premises of KIRITI MAHATO, S/O- UMESH MAHATO, VILL-BISHKUDRA, P.S- BARABAZAR, DIST- PURULIA and inspected his premises at 05:55 p.m.

During inspection, it was found that KIRITI MAHATO, S/O- UMESH MAHATO, VILL-BISHKUDRA, P.S- BARABAZAR, DIST- PURULIA was enjoying electricity illegally by direct hooking from nearest LT OH line through 2-Core PVC cable in his premises at BISHKUDRA with connected load of 0.071 KVA.

From the above arrangement he was using the following equipment:

01. 01 no Electric Bulb (60 watt)

Out of which I seized the following articles:

1. 1 no of PVC Cable (9 mtr. Approx) with hooking device.

Seizure list was prepared at site and accused person refused to sign. After process of inspection and seizure list we left the premises at about 06:10p.m.

The said person has committed an offence U/S 135(1)/a of electricity act 2003 subsequently electricity (Amendment) act- 2007.
