as follows:-



- 1... That the Complainant and accused persons have their respective shops side by side.
- 2...That the complainant collected some earth beside the road for using it in front of his shop in the renny season.
- 3...That on 30.06.18.corresponding to 14th Ashar 1424 B.S. while the complainant was in his shop at that time both the accused persons came to the shop of the complainant's and in the name of his family and abased him filthy languages as to why he kept the earth at Road side and there was some hot altercation in between the parties.

Then both the accused persons pick up a piece of wood and assaulted the complainant with the help of that wood and fist and blows over his head nose, left eye and other parts of his body. The complainant sustained grecious injuries on his left eye which becames severly damaged causing shortage of sight and over his nose oozing backs blood from nose.

4...That seeing the precarious louds of the complainant the nearby people rescused the complainant from the



clathches of the accused persons and his life was then saved.

5..That after the said sincident the complainant was treated at Basantapur P.H.C.under Boro P.S. and at Purulia Sadar Hospital.

6..That incident was then reported to the O/C Boro P.S.
But the police of the said P.S.insteadof registering
specific case directed him to compromise the matter

7..That thereafter the complainant lodged infomation to the S.P.Purulia but with same fate.

In the above circumstances the Complainant has

no oer alternative but to file the petition before
the Ld.Court as per law.
